HEARING DECISION

ISSUE

Did the Department properly deny Claimant's request for State Emergency Relief (SER) assistance with energy or utility service(s)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On May 19, 2011, Claimant applied for SER assistance with energy or utility service.
- 2. On May 24, 2011, the Department sent notice of the application denial to Claimant.
- 3. On July 26, 2011, the Department received Claimant's hearing request, protesting the SER denial.

CONCLUSIONS OF LAW

The State Emergency Relief (SER) program is established by 2004 PA 344. The SER program is administered pursuant to MCL 400.10, et seq., and by 1993 AACS R

400.7001-400.7049. Department policies are found in the State Emergency Relief Manual (ERM).

Additionally, although the Department approved Claimant's request for SER, the Claimant failed and refused to pay the required co-payment within thirty days of the approval notice. The Department, therefore, acted properly in closing Claimant's SER application.

Based on the above Findings of Fact and Conclusions of Law, and for reasons stated on the record, the Administrative Law Judge concludes that the Department properly denied improperly denied Claimant's SER application for assistance with energy and utility services.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for reasons stated on the record, finds that the Department \int \text{did act properly.} \text{did not act properly.}
