<u>ISSUE</u>	
	Did the Department properly suspend the Appellant's Home Help Services (HHS) due to not having full-coverage Medicaid?
FINDINGS OF FACT	
	Administrative Law Judge, based on the competent, material, and substantial nce on the whole record, finds as material fact:
1.	The Appellant was formerly a full-coverage Medicaid beneficiary who was receiving Home Help Services (HHS).
2.	The Appellant's Medicaid status changed from full-coverage Medicaid to spend-down effective (Exhibit 1, page 5)
3.	The Appellant's Medicaid deductible is \$ per month. (Exhibit 1, page 5)
4.	The Appellant's HHS needs have been assessed at \$ per month in HHS payments. (Exhibit 1, page 6)

- 5. The Appellant's co-pay exceeds the amount of HHS she is potentially eligible for.
- 6. The Appellant was notified that her HHS benefits would be suspended effective due to her lack of full-coverage Medicaid and her payment not meeting or exceeding her deductible amount. (Exhibit 1, page 4)
- 7. The Appellant requested an administrative hearing to contest the suspension of her HHS benefits on (Exhibit 1, page 3)

#### **CONCLUSIONS OF LAW**

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

The purpose of HHS is to enable functionally limited individuals to live independently and receive care in the least restrictive, preferred settings. These activities must be certified by a physician and may be provided by individuals or by private or public agencies.

# **ELIGIBILITY FOR HOME HELP SERVICES**

Home help services (HHS) are defined as those which the department is paying for through Title XIX (Medicaid) funds. The client must be eligible for Medicaid in order to receive these services.

# Medicaid/Medical Aid (MA)

Verify the client's Medicaid/Medical aid status.

The client may be eligible for MA under one of the following:


- All requirements for MA have been met, or
- MA deductible obligation has been met.

The client must have a scope of coverage of:

- 1F or 2F, **or**
- 1D or 1K (Freedom to work), or
- 1T (Healthy Kids Expansion).

Clients with eligibility status of 07 (Income scale 2-Non MA) and scope of coverage 20 or 2B are **not** eligible for Medicaid until they have met their MA deductible obligation.

An ILS case may be opened (service program 9) to assist the client in becoming MA eligible. However, do **not** 



authorize HHS payment prior to the MA eligibility date. The payment must be prorated if the eligibility period is less than the full month. To prorate, divide the monthly care cost by the number of days in the month. Then, multiple (sic) that daily rate by the number of eligible days.

**Note**: A change in the scope of coverage by the eligibility specialist (ES) will generate a DHS-5S for cases active to services programs 1, 7, and 9.

The material facts of this case are not in dispute. The Appellant has a monthly Medicaid deductible (spend-down). The amount of her monthly spend-down exceeds the potential HHS payments she would receive from the Department each month. Therefore, she does not qualify for the program at this time. Policy requires a HHS participant to have full-coverage Medicaid or have an HHS payment that exceeds her Medicaid deductible in order to be eligible for the HHS program.

## **DECISION AND ORDER**

The Administrative Law Judge, based on the above findings of fact and conclusions of law, decides that the Department properly suspended the Appellant's HHS benefits.

#### IT IS THEREFORE ORDERED that:

The Department's decision is AFFIRMED.
