**ORDER OF DISMISSAL**

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9; and MCL 400.37 upon claimant's request for a hearing filed on February 11, 2011. After due notice, a hearing was held June 9, 2011.

Prior to the closure of the hearing record, the department indicated that the claimant's FAP and AMP benefits had been reinstated and that the client had not lost any benefits. The claimant verified that her FAP had been reinstated and she had received her retro FAP benefits. Claimant also verified that the AMP coverage had continued and was not an issue.

Therefore, it is not necessary for the Administrative Law Judge to decide the matter that was in dispute. Pursuant to MAC R 400.906 and 400.903, claimant's hearing request is **HEREBY DISMISSED**, because claimant is no longer aggrieved by a department action.
