**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on February 27, 2011. Claimant participated and testified. Other participants were [REDACTED], Claimant's father, and [REDACTED] Claimant's spouse. [REDACTED] represented the Department of Human Services.

**ISSUE**

Did the Department of Human Services (Department) properly deny close Claimant's Family Independence Program (FIP) Food Assistance Program (FAP) Medical Assistance (MA/MSP) Adult Medical Assistance (AMP) State Disability Assistance (SDA) Child Development and Care (CDC) application case due to a failure to comply with the verification requirements?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, including testimony of witnesses finds as material fact:

1. Claimant applied for was receiving: FIP FAP MA/MSP SDA CDC.
2. Claimant was provided with a Verification Checklist (DHS -3503), requesting picture IDs of Claimant and spouse and Social Security card by February 22, 2011.
3. On April 1, 2011, the Department denied closed Claimant's application case for failure to submit verification of picture identifications of Claimant and spouse and Social Security card in a timely manner.

4. On April 1, 2011, the Department sent notice of the  denial  closure of Claimant's  application  case.
5. On March 9, 2011, Claimant filed a hearing request, protesting the  denial  closure of the  application  case.

### **CONCLUSIONS OF LAW**

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 42 USC 601, *et seq.* The Department (formerly known as the Family Independence Agency) administers the FIP program pursuant to MCL 400.10, *et seq.*, and 1997 AACS R 400.3101-3131. The FIP program replaced the Aid to Dependent Children (ADC) program effective October 1, 1996. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, *et seq.*, and 1997 AACS R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, *et seq.*, and 1998-2000 AACS R 400.3151-400.3180. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The Child Development and Care program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and 1997 AACS R 400.5001-5015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

Based on the above Findings of Fact, the Administrative Law Judge concludes that the Department  properly  improperly  denied  closed Claimant's  application  case.


### DECISION AND ORDER
