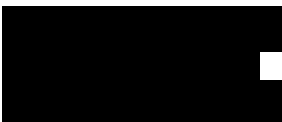

HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on [REDACTED]. The Claimant appeared personally and testified.

ISSUE

Did the Department properly deny the claimant's State Disability Assistance (SDA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], the claimant applied for SDA.
2. On [REDACTED], the department denied the claimant's SDA application for excess income.
3. The claimant receives RSDI income in the amount of \$824.00 per month.

4. On [REDACTED], the claimant filed a request for a hearing.

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, et seq., and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).


The claimant receives RSDI income in the amount of \$824.00 per month.

Here, the claimant's net income is above the limit for receiving SDA. The claimant has a SDA group of one and the limit is \$269.00 per month (RFT 225). The claimant's income is \$824.00 per month. The department was correct in denying the claimant's SDA application.

This ALJ sympathizes with the claimant but there is nothing that can be done.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, AFFIRMS the Department decisions in this matter.
