**RECONSIDERATION DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MCL 400.37; and MAC R 400.919(3) upon claimant's request for a reconsideration.

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. On March 15, 2011, the undersigned Administrative Law Judge issued a decision and order in the above-captioned matter regarding claimant's divestment penalty application.
2. The 20089334 Hearing Decision is entirely adopted and incorporated by reference herein except for the last paragraph in the decision and order where a clerical error occurred.
3. The entire decision stands. The department was and is reversed as to the application date of the divestment penalty. The only change is the wording in the last paragraph as indicated herein.
4. On March 24, 2011, claimant's counsel identified a clerical error in the last paragraph and requested correction.
5. On April 1, 2011, Administrative Law Judge Manager Marya Nelson-Davis issued an Order for Reconsideration assigning the case to the undersigned Administrative Law Judge.

As noted in the Findings of Fact, the entire previous hearing decision is adopted and incorporated by reference herein. The only change is the last paragraph in the Decision and Order which should read as follows:

Accordingly, the department's application of a divestment period beginning in May, 2007 was incorrect. The department is Ordered to reprocess this case with a divestment penalty beginning December, 2006 for 13 months. The divestment period is to expire at the end of December, 2007. The department is Ordered to reimburse claimant for any monies owed at the end of the new divestment period—beginning January, 2008; the department shall reimburse claimant monies from January 2008 through May 2008 for the long-term care.
