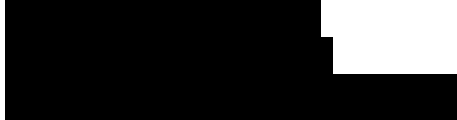

HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on January 6, 2011. The claimant appeared and testified.

ISSUE

Did the Department properly deny the Claimant's application for State Emergency Assistance (SER) to pay rent?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On October 5, 2010, the claimant filed an application for shelter relocation.
2. On October 8, 2010, the department denied the SER application.
3. On October 8, 2010, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The State Emergency Relief (SER) program is established by 2004 PA 344. The SER program is administered pursuant to MCL 400.10, *et seq.*, and by final administrative rules filed with the Secretary of State on October 28, 1993. Michigan Administrative Code Rules R 400.7001-400-7049. Department of Human Services (formerly known as the Family Independence Agency) policies are found in the State Emergency Relief Manual (SER).

Legal Notice

A court summons, order, or judgment was issued which will result in the SER group becoming homeless. (ERM 303, p.3).

Here, the claimant did not provide a summons, order, or judgment as proof of her impending eviction.

This ALJ finds that the department was correct in denying the claimant's SER application.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of law, AFFRIMS the Department's decision.
