HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on [REDACTED]

ISSUE

Was the denial of claimant's application for MA-P for lack of disability correct?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant applied for MA-P and retroactive MA-P on [REDACTED].
- (2) On [REDACTED], the Medical Review Team denied MA-P.
- (3) On [REDACTED], claimant filed for hearing.
- (4) On [REDACTED] the State Hearing Review Team denied MA-P and SDA.

- (5) On [REDACTED] a hearing was held before the Administrative Law Judge.
- (6) The Social Security Administration issued a decision in claimant's case, finding disability for the purpose of securing SSI and RSDI income.
- (7) The Social Security Administration gave claimant a disability onset date of [REDACTED]
- (8) Claimant was represented at hearing by [REDACTED] of [REDACTED]

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or Department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

Department policy at BEM 260 states that if a claimant has been found eligible for either SSI or RSDI based upon a finding of disability, the person meets the Department's MA disability criteria. No other evidence is required to establish disability. In the present case, the claimant was found by the Social Security Administration to be eligible for RSDI and SSI benefits based upon disability, and have presented prima facie evidence of the same. This disability was found by the Social Security Administration to have an onset date of [REDACTED], which is an onset date

prior to the claimant's MA-P request. Therefore, the Administrative Law Judge finds that the claimant met the Department's definition of disabled for the purposes of MA-P.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant is medically disabled for the purposes of the MA program, pending a review of all non-medical eligibility factors.

Accordingly, the Department's decision in the above stated matter is, hereby, REVERSED.

The Department is ORDERED to process claimant's Medicaid application of [REDACTED] and initiate a review of all non-medical eligibility factors, if it has not already done so.

The Department is further ORDERED to initiate a full review of this case in [REDACTED]
