**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was held on September 7, 2011 in Detroit, Michigan. Claimant appeared and testified. The Department of Human Services (Department) was represented by [REDACTED] JET Case Manager.

**ISSUE**

Was the Department correct in its decision to deny Claimant's CDC application?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for CDC for the month of March, 2011.
2. Claimant applied for CDC on April 5, 2011.
3. The Department denied Claimant's application of April 5, 2011.
4. Claimant requested a hearing on June 10, 2011.
5. At the hearing, the Department agreed to re-register and reprocess Claimant's March, 2011 application and make a determination of Claimant's eligibility for the month of March 2011.

6. As a result of the agreement, Claimant indicated that she no longer wished to proceed with the hearing.

### **CONCLUSIONS OF LAW**

The CDC program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and MAC R 400.5001-5015. Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).


Under BAM 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The Department provides an Administrative Hearing to review the decision and determine if it is appropriate. Department policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the Department receives a hearing request and continues through the day of the hearing.

In the present case, the Department has agreed to re-register and reprocess Claimant's CDC application of March 2011 and make a determination of Claimant's eligibility for the month of March 2011. As a result of this agreement, Claimant indicated she no longer wished to proceed with the hearing. Since the Claimant and the Department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law decides that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing. Therefore, it is ORDERED:

1. The Department shall re-register Claimant's March 2011 application for CDC.
2. The Department shall determine Claimant's eligibility for CDC for the month of March 2011.
3. If Claimant is found to be eligible for CDC for the month of March 2011, the Department shall issue supplemental payments for the month of March 2011.
