**ORDER OF DISMISSAL**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing dated 5/12/11. After due notice, a telephone hearing was held on August 17, 2011 from Detroit, Michigan. Ronald Spaniol appeared and testified as Claimant's authorized hearing representative (AHR). [REDACTED] also appeared and testified on behalf of Claimant. On behalf of Department of Human Services (DHS), Colleen Carey, Manager, and Muafaq Ambaneh, Specialist, appeared and testified.

Claimant's AHR originally requested a hearing to dispute an unspecified issue concerning a reduction in Food Assistance Program (FAP) benefits effective 5/2011. Shortly after commencement of the hearing, Claimant's AHR conceded that DHS corrected the actions that led to the request of the hearing. Though Claimant's AHR stated there was a subsequent DHS action was also in dispute, that action had nothing to do with why Claimant requested a hearing on 5/12/11. It was recommended that Claimant request a new hearing if there was a subsequent DHS action in dispute. There are no DHS actions in dispute stemming from Claimant's hearing request dated 5/12/11. Accordingly, pursuant to MAC R 400.906 and 400.903, Claimant's hearing request is hereby DISMISSED.
