**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was held on August 15, 2011 in Detroit, Michigan. Claimant appeared and testified. FIM [REDACTED] and Case Manager [REDACTED] appeared on behalf of the Department of Human Services (Department).

**ISSUE**

Was the Department correct in denying Claimant's Food Assistance Program (FAP) application?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for FAP on July 5, 2011.
2. The Department denied Claimant's FAP application due to a person being listed as Claimant's step-father, even though this person was not legally married to Claimant's mother, now deceased.
3. Claimant requested a hearing, protesting the FAP application denial.
4. At the hearing, the Department agreed to reinstate and reprocess Claimant's July 5, 2011 FAP application with corrected information.
5. As a result of this agreement, Claimant stated she no longer requested a hearing.

**CONCLUSIONS OF LAW**

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to CML 400.10 *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).


Under Bridges Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The department provides an Administrative Hearing to review the decision and determine if it is appropriate. Department policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the department receives a hearing request and continues through the day of the hearing.

In the present case the Department has agreed to reinstate and reprocess Claimant's July 5, 2011 FAP application with corrected information. As a result of this agreement, Claimant indicated she no longer wished to proceed with the hearing. Since the Claimant and the Department have come to an agreement, it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above findings of fact and conclusions of law decides that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing. Therefore, it is ORDERED:

1. The Department shall reinstate and reprocess Claimant's July 5, 2011 FAP application with corrected information.
2. Issue any missed FAP payments, if Claimant is otherwise eligible.
