HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was held on January 13, 2011. Claimant appeared and testified. [REDACTED], a friend of Claimant's, was also present. The Department of Human Services (Department) was represented by [REDACTED].

ISSUE

Was the Department correct in closing Claimant's Medical Assistance (MA) program case?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

1. Claimant was an ongoing Qualified Medicaid Beneficiary (MA-QMB) recipient.
2. Claimant received \$475.00 in Retirement, Survivors and Disability Income (RSDI) and \$630.67 per month in Unemployment Compensation (UC) benefits.
3. Claimant's MA-QMB was closed due to excess income on November 19, 2010.
4. Claimant requested a hearing on November 22, 2010.
5. At the hearing, the Department agreed to reinstate claimant's MA case under Additional Low Income Beneficiaries (ALMB), retroactive to the date of closure.

6. As a result of this agreement, Claimant indicated that she no longer wished to proceed with the hearing.

CONCLUSIONS OF LAW


The MA program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

Under BAM Item 600, clients have the right to contest any Department decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The Department provides an Administrative Hearing to review the decision and determine if it is appropriate. Department policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the Department receives a hearing request and continue through the day of the hearing.

In the present case, the Department has agreed to reinstate Claimant's MA case under ALMB, retroactive to the date of closure. As a result of this agreement, Claimant indicated she no longer wished to proceed with the hearing. Since Claimant and the Department have come to an agreement, it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing. Therefore, it is ORDERED that the Department reinstate Claimant's MA case under ALMB, retroactive to the date of closure, in accordance with this settlement.
