

Participants on behalf of the Departm ent of Human Services (Department) included Family Independence Manager.


The Michigan Administrative Code R 400.903(1) provides as follows:

An opportunity for a hearing shall be granted to an applicant who requests a hearing becaus e his c laim for assistance is denied or is not acted upon with reasona ble prompt ness, and to any recipient who is aggrieved by an agency action resulting in suspension, r eduction, dis continuance, or termination of assistance.

In this case, on December 17, 2011, the Department

	denied Claimant's application for benefits
	closed Claimant's case for benefits

Medical Assistance (MA).

Adult Medical Assistance (AMP).
State Disability Assistance (SDA).
Child Development and Care (CDC).

State Emergency Services (SER).

Claimant requested a hearing to dispute the Department's action. Shortly after commencement of the hearing, Claimant testified that he now understood and accepted the actions taken by the Department. Claimant also testified that he understood that the Department was processing his Medical A ssistance (MA) application for his wif e. Claimant testified t hat he did not wish to proceed wi th a hearing. The Department agreed to the dismiss al of Claimant's hearing request. Pursuant to MAC R 400.906(1), Claimant's hearing request is hereby DISMISSED.

**NOTICE:** Michigan Administrative Hearing Syst em (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a par ty within 30 days of the mailing date of this Dec ision and Order . MAHS will not order a rehearing or reconsideration on the Department's mo tion where the final decis ion cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration <u>MAY</u> be granted for any of the following reasons:
  - misapplication of manual policy or law in the hearing decision,
  - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
  - the failure of the ALJ to address other relevant issues in the hearing decision.
