CONCLUSIONS OF LAW
Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).
☐ The Adult Medical Program (AMP) is established by 42 USC 1315, and is administered by the Department pursuant to MCL 400.10, <i>et seq</i> .
☐ The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 42 USC 601, et seq. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10, et seq., and 1999 AC, Rule 400.3101 through Rule 400.3131. FIP replaced the Aid to Dependent Children (ADC) program effective October 1, 1996.
The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, et seq., and 1999 AC, Rule 400.3001 through Rule 400.3015.
☐ The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, <i>et seq.</i> , and MCL 400.105.
☐ The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, is established by 2004 PA 344. The Department (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, et seq., and 2000 AACS, Rule 400.3151 through Rule 400.3180.

Additionally, the Department used asset information supplied by the Claimant in May 2011, when his case was opened for other benefits. In November 2011 when the Claimant applied for FAP benefits, and as part of the mass update due to the change in policy effective October 1, 2011, the Department determined that the Claimant's assets

had not changed since May 2011 and denied the FAP application due to excess assets. At the time of the FAP application the Department relied upon a Certificate of Deposit in the amount of \$9987.36 for Janet Hughes to deny the application. The information relied upon indicated that the certificate expired September 24, 2011. Exhibit 2. At the hearing, the Claimant provided information regarding the certificate indicating that the money had been transferred to a checking account at maturity and that in September 2011 the account contained its lowest daily balance for September 2011 which was \$4207.37. Claimant Exhibit 1. The account information was not sought by the Department through a verification checklist at the time of the application. Instead the Department relied on old information. The Department denied the Claimant's application due to its determination that the Claimant's assets exceeded the \$5,000 FAP asset limitation. BEM 400. The Department relied on old stale information and denied the Claimant's FAP application. The information the Department relied upon was not the best available information, and the Claimant's current assets should have been updated and verified before the denial of the application. The Department relied upon a May 2011 account balance as a basis for the denial, due to excess assets. this information relied on did not accurately reflect FAP assets in November 2011.

Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that, due to excess assets, the Department

properly denied Claimant's application improperly denied Claimant's application properly closed Claimant's case improperly closed Claimant's case

for: for: AMP FIP FAP MA SDA CDC.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department did act properly.

Accordingly, the Department's AMP FIP FAP MA SDA CDC decision is AFFIRMED REVERSED for the reasons stated on the record.

1. The Department is ordered to initiate reinstatement of the Claimant's FAP application retroactive to the date of application, November 17, 2011.

THE DATE OF MAILING OF THIS DECISION AND ORDER:

2. The Department shall seek further verification of assets from the Claimant by verification checklist to determine the Claimant's FAP eligibility.

- 3. The Claimant shall have 10 days to respond to any verification of assets sought by the Deparatment.
- The Department shall issue a supplement to the Claimant for any FAP benefits he is otherwise eligible to receive, in accordance with Department policy, retroactive to the date of application.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases).

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
