Additionally, the Department could not explain how it arrived at the actions of August 8, 2011. As Department error very possibly occurred here with regard to the August 8, 2011, reduction of Claimant's FAP benefits from \$367 to \$233 and the imposition of a Medicaid Patient Pay Amount (spend-down) requirement with Claimant's MA benefits, the calculations must be reviewed.

DECISION AND ORDER

oxtimes THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 1. Initiate procedures to review Claimant's August 8, 2011, FAP allotment and Medicaid Patient Pay Amount;
- 2. Initiate procedures to provide ongoing and supplemental retroactive FAP and MA benefits to Claimant at the benefit levels to which he is entitled.
- 3. All steps shall be taken in accordance with Department policy and procedure.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome
 of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
