The Department provides services to adults and children pursuant to MCL 400.14(1) and 1999 AC, Rule 400.5001 through Rule 400.5015.
Additionally, it is found and determined that there was a Claimant error in this case. Claimant is Bengali and did not understand that he had to submit his bank statement with the Redetermination application. Claimant provided full bank account information on the Redetermination Form. Claimant brought the proper bank account information to the hearing.
It is found and determined that Claimant has not refused to cooperate with the Department and, therefore, the Department must protect his right to benefits. In this case, a language barrier may have caused Claimant's misunderstanding; but, whatever caused it, it was not a refusal to cooperate with the Department. BAM 105, "Rights and Responsibilities."
Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department

DECISION AND ORDER
The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department did act properly. did not act properly.
Accordingly, the Department's \square AMP \square FIP \boxtimes FAP \boxtimes MA \square SDA \square CDC decision is \square AFFIRMED \boxtimes REVERSED for the reasons stated on the record.

1. Reinstate Claimant's FAP and MA benefits;

THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 2. Initiate procedures to process Claimant's Redetermination application, including a review of Claimant's bank statement;
- 3. Initiate procedures to determine if Claimant's benefit levels are correct;
- 4. Initiate procedures to provide ongoing and retroactive FAP and MA benefits to Claimant at the benefit levels to which he is entitled.

5. All steps shall be taken in accordance with Department policy and procedure.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome
 of the original hearing decision.
- A reconsideration MAY be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
