Additionally, at the hearing, the Claimant produced evidence that prior to the closure of the case and before the verification checklist due date, the Claimant submitted the requested information to the Department. The Claimant faxed some of the information, and credibly testified that he dropped off the remainder of the information, including the rent verification, at the Department on the 4/26/12 due date. The Claimant's testimony was credible and the Department offered no rebuttal. Therefore, it is found and determined that the Department should not have closed the Claimant's SDA case for refusal to verify information or complete the redetermination. Department of Human Service Bridges Administrative Manual (BAM) 130. (2011).

Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department properly improperly

☑ THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. The Department shall initiate reinstatement of the Claimant's SDA case retroactive to the date of closure (5/1/12) and complete the redetermination, if not already

completed and satisfied by the information already provided to the Department.

2. The Department shall issue a supplement to the Claimant for SDA benefits the

Claimant was otherwise entitled to receive, in accordance with Department policy.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome
 of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
