FIP replaced the Aid to Dependent Children (ADC) programe effective October 1, 1996.
∑ The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS program] is established by the Food Stamp Act of 1977, as amended, and implemented by the federal regulations contained in Title 7 of the Code of Federa Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, et seq., and 1999 AC, R 400.300 through Rule 400.3015.

Claimant may request a rehearing or reconsideration for the following reasons:

- A reconsideration MAY be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address other relevant issues in the hearing decision.
