# FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

☐ The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, is established by 2004 PA 344. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, et seq., and 2000 AACS, Rule 400.3151 through Rule 400.3180.
☐ The Child Development and Care (CDC) program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and 1999 AC, Rule 400.5001 through Rule 400.5015.
☐ The State Emergency Relief (SER) program is established by 2004 PA 344. The SER program is administered pursuant to MCL 400.10, <i>et seq.</i> , and by 1999 AC, Rule 400.7001 through Rule 400.7049. Department policies are found in the State Emergency Relief Manual (ERM).

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: the Department agreed to reinstate the Claimant's FIP case retroactive to the date of closure, August 1, 2012, and restore the Claimant to her food assistance group retroactive to her removal from the group on August 1, 2012. The Department further agreed to remove from its records, the sanction which it imposed for non compliance with Work First as a result of a triage held on June 7, 2012.

As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

## **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

## THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

- 1. The Department shall initiate reinstatement the Claimant's FIP case retroactive to the date of closure, August 1, 2012.
- 2. The Department shall initiate actions to restore the Claimant to her food assistance group retroactive to her removal from the group on August 1, 2012.

- 3. The Department shall initiate removal from its records, the sanction which it imposed for non compliance with Work First as a result of a triage held on June 7, 2012.
- 4. The Department shall issue a supplement for both FIP and FAP benefits the Claimant was otherwise entitled to receive in accordance with Department policy.

(60 days for FAP cases).

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
