The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and 1999 AC, Rule 400.5001 through Rule 400.5015.
In the present case, the Department closed Claimant's FIP case due to her allegedly not participating in employment-related activities. At the hearing, however, the Department representative did not have documents to present for examination, and Claimant stated that she did not receive a hearing packet. Although some documents were in the file that this Administrative Law Judge possessed at the hearing, since it was a telephone hearing, there were no documents that Claimant could review to defend her case. In addition, the Department offered no convincing testimony that Claimant failed to participate in employment-related activities. Without proof that Claimant failed to participate in employment-related activities, it cannot be found that the Department was correct in closing Claimant's case.
Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department

3. Issue FIP supplements, August 1, 2012 and ongoing, in accordance with Department policy.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the mailing of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the mailing date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome
 of the original hearing decision.
- A reconsideration MAY be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
