HEARING DECISION

This matter is before the undersigned Ad request for a hearing made pursuant to Mi which gov ern the administrative hearing a telephone hearing was commenced on J Claimant personally appeared and testified. Participants on behalf of the Department of Human Services (Department) included Medical Contact Worker

ISSUE

Did the Department of Human Services (DHS) pr operly deny Claimant 's Medic al Assistance (MA), Retro-MA and State Disability Assistance (SDA) application?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On May 22, 2012, Claimant filed an application for MA/Retro-MA and SDA benefits, alleging disability.
- (2) On August 16, 2012, 2012, the M edical Review Team (MRT) denied Claimant's application indicating he was capable of performing other work, pursuant to 20 CFR 416.920(f). (Dept Ex. A, pp 2-3).
- (3) On August 22, 2012, the department caseworker sent Claimant notice that his application was denied.
- (4) On September 14, 2012, Claim ant filed a request for a hearing to contest the department's negative action.

- (5) On October 24, 2012, the State Hearing Review Team (SHRT) found Claimant was not disabled and retai ned the capacity to perform a wide range of light work. (Dept Ex. B, pp 1-2).
- (6) At the time of the hearing, Claimant was 48 years old with a birth date; was 5'9" in height and weighed 293 pounds.
- (7) Claimant is a high school graduate.
- (8) Claimant was appealing the denial of Social Security disability benefits at the time of the hearing.
- (9) Claimant does not have a history of alcohol/nicotine or drug addiction.
- (10) Claimant has a valid driver's license and is able to drive.
- (11) Claimant is not currently workin g. He last worked in April, 201 2, as a machine operator for 4 months and prior to that, as a Security Officer for 0 years and before that as a press operator for 8 years.
- (12) Claimant alleges disability on the basis of seve re lumbar spinal stenosis, lumbar radiculopathy, scolios is, s pondylisthesis, rotator cuff tear, diverticulitis, gout, uncontrolled hyper tension, insulin dependent diabetes, arthritis, tendonitis, and degenerative disc disease.
 - (13) Medical evidence indicates Claimant's condition is deteriorating and he is in need of a lower lumbar fusion. He had been s cheduled for back surgery in April, 2012, but that was postponed due to his poorly controlled blood pressure. He also requir es assistance in the home with dressing, cooking, cleaning, laundry, and housework.

CONCLUSIONS OF LAW

The State Disability A ssistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Service s (DHS or department) admin isters the SDA program pursuant to MCL 400.10, *et seq.*, and Mich Admin Code, Rules 400.3151-400.3180. Department policies are found in the Bridges Administrative Manual (BAM), th *e* Bridges Eligibilit y Manual (BEM) and the Reference Tables Manual (RFT).

Current legislative amendments to the Act delineate eligibility criteria as implemented by department policy set forth in program manuals. 2004 PA 344, Sec. 604, es tablishes the State Disability Assistance program. It reads in part:

Sec. 604 (1). The department sha ll operate a state di sability assistance program. Except as provided in subsection (3),

persons eligible for this program shall include needy cit izens of the United States or aliens exempt from the Supplemental Security Income citizenship re quirement who are at least 18 years of age or emancipated minors meeting one or more of the following requirements:

(b) A per son with a physical or mental impairment whic h meets federal SSI disab ility standards, exce pt that the minimum duration of the dis ability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Specifically, this Act provides minimal cash assistance to individuals with some type of severe, temporary disability which prevents him or her from engaging in substantial gainful work activity for at least ninety (90) days.

The Medical Assistance (MA) program is estab lished by Title XIX of the Social Sec urity Act and is implemented by T itle 42 of the C ode of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

In order to receive MA benefits based upon disa bility or blindness, claimant must be disabled or blind as defined in T itle XVI of the Social Security Act (20 CFR 416.901). DHS, being authorized to make such dis ability determinations, utilizes the SSI definition of disability when making medical decisions on MA applications. MA-P (disability), also is known as Medicaid, which is a progr am designated to help public assistance claimants pay their medical expenses. Mi chigan administers the federal Medicaid program. In assessing eligibility, Michigan utilizes the federal regulations.

Relevant federal guidelines provide in pertinent part:

"Disability" is:

... the inability to do any subs tantial gainful activity by reason of any medically dete rminable physical or mental impairment which c an be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months. 20 CFR 416.905.

The federal regulations require t hat seve ral considerations be analyzed in s equential order:

... We follow a set order to determine whether you are disabled. We review any current work activity, the severity

of your impairment(s), your residual functional capacity, your past work, and your age, educati on and work experience. If we can find that you are disabled or not disabled at any point in the review, we do not review your claim further. 20 CF R 416.920.

The regulations require that if disability can be ruled out at any step, analysis of the next step is not required. These steps are:

- 1. If you are working and the work you are doing is substantial gainful activity, we will find that you are not dis abled regardless of your medical condition or your age, education, and work experienc e. 20 CFR 416.920(b). If no, the analysis continues to Step 2.
- 2. Does the client have a severe impairment that has lasted or is expected to last 12 months or more or result in deat h? If no, the client is ineligible for MA. If yes, the analysis continues to Step 3. 20 CFR 416.909(c).
- 3. Does the impairment appear on a special Listing of Impairments or are the clie nt's symptoms, signs, and laboratory findings at least equiv alent in severity to the set of medical findings specified for the listed im pairment that meets the duration requirement? If no, the analysis continues to Step 4. If yes, MA is approved. 20 CFR 416.920(d).
- 4. Can the client do the former work that he/she performed within the last 15 years? If yes, the client is ineligible for MA. If no, the analys is continues to Step 5. Sections 200.00-204.00(f)?
- 5. Does the client hav e the Residual Func tional Capacity (RFC) to perform other work according to the guidelines set forth at 20 CFR 404, Subpart P, Appendix 2, Sections 200.00-204.00? This step consider s the residual functional capacity, age, education, and past work experience to see if the client can do other work. If yes, the analysis ends and the client is ineligible for MA. If no, MA is a pproved. 20 CFR 416.920(g).

At application claimant has the burden of proof pursuant to:

... You must provide medical evidence showing that you have an im pairment(s) and how seve re it is during the time you say that you are disabled. 20 CFR 416.912(c).

Federal regulations are very specific regarding the type of medical evidence required by claimant to establish statutory disability. The regulations essentially require laboratory or clinical medical reports that corroborate claimant's claims or claimant's physicians' statements regarding disability. These regulations state in part:

Medical reports should include --

- (1) Medical history.
- (2) Clinical findings (such as the results of physical or mental status examinations);
- (3) Laboratory findings (such as sure, X-rays);
- (4) Diagnosis (statement of di sease or injury based on its signs and symptoms). 20 CFR 416.913(b).

Statements about your pain or other symptoms will not al one establish that you are disabled; there must be medical signs and laboratory findings which show that you have a medical impairment. 20 CFR 416.929(a). T he medical evidenc e must be complete and detailed enough to allow us to mak e a determination about whether you are disabled or blind. 20 CFR 416.913(d).

Medical findings consist of symptoms, signs, and laboratory findings:

- (a) **Sy mptoms** are your own description of your physical or mental impairment. Y our statements alone are not enough to establish t hat there is a physic al or mental impairment.
- (b) Signs are anatomical, physiological, or psychological abnormalities which can be obs erved, apart from your statements (symptoms). Si gns must be shown by medically acceptable clinic al diagnostic t echniques. Psychiatric signs are medically demonstrable phenomena which indic ate s pecific ps ychological abnormalities e.g., abnormalit ies of behavior, mood, thought, memory, orientat ion, development, or perception. They must al so be shown by observable facts that can be medically described and evaluated.

(c) Laboratory findings are anatomical, phy siological, or psychological phenomena which can be s hown by the use of a medically accept able laboratory diagnostic techniques. Some of these diagnostic techniques include chemical tes ts, el ectrophysiological studies (electrocardiogram, electroencephalogram, etc.), roentgenological studies (X -rays), and psychologic al tests. 20 CFR 416.928.

It must allow us to determine --

- (1) The nature and limiting effects of your impairment(s) for any period in question;
- (2) The probable duration of your impairment; and
- (3) Your residual functional capac ity to do work-related physical and mental activities. 20 CFR 416.913(d).

Information from other sources may also help us to understand how your impairment(s) affects your ability to work. 20 CFR 416.9 13(e). You can only be found disabled if yo u are unable to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death, or which has lasted or can be expected to last for a continuous period of not less than 12 months. See 20 CFR 416.905. Your impairment must result from anatomical, physiologic al, or psychological abnormalities which are demons trable by medically acc eptable clinical and laboratory diagnostic techniques. 20 CFR 416.927(a)(1).

Applying the sequential analys is herein, Claimant is not ine ligible at the first step as Claimant is not currently working. 20 CFR 416.920(b). The analysis continues.

The second step of the analysis looks at a two-fold assessment of duration and severity. 20 CFR 416.920(c). This second step is a *de min imus* standard. Ruling a ny ambiguities in Claimant's favor, this Administrative Law Judge (ALJ) finds that Claimant meets both. The analysis continues.

The third step of the analysis looks at whet her an individual meets or equals one of the Listings of Impairments. 20 CFR 416.920(d). Claimant does not. The analys is continues.

The fourth step of the analysis looks at the ab ility of the ap plicant to return to past relevant work. This step ex amines the physical and mental demands of the work done by Claimant in the past. 20 CF R 416.920(f). In this case, th is ALJ finds that Claimant cannot return to past relevant work on the bas is of the medical evidence. The analysis continues.

The fifth and final step of the analysis applie s the biographical data of the applic ant to the Medical Vocational Grids to determine the residual functional capacity of the applicant to do other work. 20 CFR 416.920(g). After a careful review of the credible and substantial evidence on the whole rec ord, this Administrative Law Judge finds that Claimant could not do a full range of sedent ary work pursuant to Medical Vocational Grid Rule Footnote 201.00(h) due to multiple impairments and his need for back surgery and positive bilateral leg raises documented by the medical evidence.

In this case, Claimant's MRI and the evid ence purs uant to his treating neurologis t documents Claimant's of need for spinal surgery. This evidence, as already noted, does rise to statutory disability. It is not ed that at review Claimant's surgery will be assessed as controlling with regards to continuing eligibility.

DECISION AND ORDER

The Administrative Law Judge, based upon t he above findings of fact and conclusion s of law, decides the department erred in determining Claimant is not currently disabled for MA/Retro-MA and SDA eligibility purposes.

Accordingly, the department's decision is **REVERSED**, and it is ORDERED that:

- 1. The depart ment shall process Cla imant's May 22, 2012, MA/Retro-MA application, and shall award him all the benefits he may be entitled to receive, as long as he meets the remaining financ ial and non-financ ial eligibility factors.
- 2. The department shall rev iew Claimant's medica I cond ition for improvement in February, 2014, unless his Social Security Administration disability status is approved by that time.
- 3. The department shall obtain updated medical evidence from Claimant's treating physicians, physical therapists, pain clinic notes, etc. regarding his continued treatment, progress and prognosis at review.

It is SO ORDERED.
