CONSENT ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on August 6, 2012, from Detroit, Michigan. Participants on behalf of Claimant included the claimant and [REDACTED] the claimant's sister. Participants on behalf of the Department of Human Services (Department) included [REDACTED]

The Mich Admin Code R 400.903(1) provides as follows:

An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by an agency action resulting in suspension, reduction, discontinuance, or termination of assistance.

In this case, on April 1, 2012, the Department

- denied Claimant's application for benefits
- closed Claimant's case for benefits
- reduced Claimant's benefits

Claimant requested a hearing to dispute the Department's action. Shortly after commencement of the hearing, Claimant testified that s/he now understood and accepted the actions taken by the Department. The department testified that the claimant's MA was closed because she was active under a different case and the FI M at the hearing would attempt to resolve the duplicate case. Claimant also testified that s/he did not wish to proceed with a hearing. The Department agreed to the dismissal of Claimant's hearing request. Pursuant to Mich Admin Code R 400.906(1), Claimant's hearing request is hereby DISMISSED.

Based on the above discussion, it is ORDERED that this matter is DISMISSED pursuant to Mich Admin Code R 400.906(1).
