ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9; and MCL 400.37 upon claimant's request for a hearing filed on [REDACTED]. After due notice, a hearing was held [REDACTED]

Prior to the closure of the hearing record, the claimant indicated that he was active on the Food Assistance Program (FAP) and wanted to apply for State Disability Assistance (SDA) now that he had medical records he could turn in. The claimant testified that he had been communicating with Michigan Rehabilitation Services (MRS) and had now seen their physician and was waiting to hear if he could participate with them. This would entitle the claimant to SDA benefits. The department case worker indicated that she would call MRS and see what information she could find out from them. The case worker also advised the claimant to submit another SDA application as she had not received the one he indicated he had completed. The claimant testified that this resolved his hearing issue.

Therefore, it is not necessary for the Administrative Law Judge to decide the matter that was in dispute. Pursuant to MAC R 400.906 and 400.903, claimant's hearing request is **HEREBY DISMISSED**, because claimant is no longer aggrieved by a department action.

MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

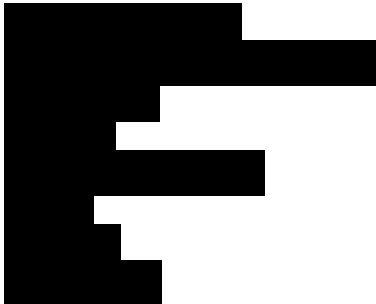
Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
