HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on January 28, 2013, from Detroit, Michigan. Participants on behalf of Claimant included the Claimant. Participants on behalf of the Department of Human Services (Department) included , Family Independence Specialist.

ISSUE

Did the Department properly deny Claimant's application close Claimant's case for:

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for benefits received benefits for:

2. On September 1, 2012, the Department
 denied Claimant's application closed Claimant's case
due to a determination that she failed to submit her Redetermination application
form.
3. On August 28, 2012, the Department sent
 Claimant Claimant's Authorized Representative (AR)
notice of the denial. closure.
4. On August 30, 2012, Claimant filed a hearing request, protesting the
 denial of the application. closure of the case.

CONCLUSIONS OF LAW

Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, *et seq.*, and 1999 AC, Rule 400.3001 through Rule 400.3015.

Additionally, Bridges Administrative Manual (BAM) 105, "Rights and Responsibilities," requires the Department to determine eligibility, provide benefits, and protect client rights. BAM 105 also require the client to cooperate fully with the Department's requests for information and documentation. Department of Human Services Bridges Administrative Manual (BAM) 105 (2012). This policy is applicable to this case.

In this case, the Department testified it did not receive the Claimant's required Redetermination application form, and accordingly terminated her FAP benefits. At the hearing Claimant did not present a copy of the Redetermination form that she claimed she submitted. Instead, she testified that she turned it in on or about Wednesday, July 31, 2012, two days before the due date. However, before the hearing began, Claimant advised the Department Specialist that she turned it in late, on August 15, 2012. When she was asked to explain the inconsistency at the hearing, she stated she really didn't remember the date, but that it was two days before the telephone hearing was scheduled.

Based on all of the evidence and testimony in this case, it is found and determined that there is insufficient testimony to establish that the Claimant cooperated with the Department in submitting the required forms. The Claimant presented only her testimony as to this matter, and, whether or not her testimony was inconsistent with her pre-hearing statement, her testimony alone with no accompanying documentation, is insufficient to prove that she cooperated. The Department shall be affirmed.

Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department



NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
