The Child Development and Care (CDC) program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and 1999 AC, R 400.5001 through Rule 400.5015.			
Additionally, the claimant was a recipient of SSI payments which made her eligible for MA and State SSI as long as she received a regular 1 st of the month check from SSI. The department was informed by SS that the claimant was no longer a recipient of SSI. During the hearing, the claimant stated that her SSI case was closed by SS because she has excess income since she is receiving her husband's death benefits. As a result, the claimant no longer receives SSI.			
The department has met their burden that the department correctly closed the claimant's MA and State SSI because the claimant was no longer eligible for SS SSI. The claimant is eligible to apply for MA based on disability.			
Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
- · misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address other relevant issues in the hearing decision.
