# SETTLEMENT ORDER

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on April 22, 2013, from Detroit, Michigan. Participants on behalf of Claimant included Claimant and Claimant's son, disabled individual who received Medical Assistance (MA) coverage. Participants on behalf of the Department of Human Services (Department) included Eligibility Specialist, and the matter of the Matter of Matter of Matter of Matter of Matter , Family Independence Manager.

#### ISSUE

Whether the Department properly provided Claimant's son with MA coverage with a \$647 monthly deductible?

## FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Claimant's son, a disabled individual, is an ongoing recipient of MA.
- 2. After the Department became aware that Claimant began receiving Retirement, Survivors, and Disability Insurance (RSDI), it reassessed Claimant's MA eligibility.
- 3. On October 29, 2012, the Department notified Claimant that effective October 1, 2012, her son's MA coverage would change to deducible coverage.

4. On November 1, 2012, Claimant filed a request for hearing concerning the Department's action.

## CONCLUSIONS OF LAW

Department policies are found in the Department of Human Services Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), Reference Tables Manual (RFT), and State Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: (i) begin reviewing and reprocessing Claimant's son's eligibility for Disabled Adult Child (DAC) MA coverage as of October 1, 2012, ongoing; (ii) provide the son with MA coverage he is eligible to receive from October 1, 2012, ongoing; and (iii) notify Claimant in writing of the Department's decision in accordance with Department policy.

As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

#### **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

- 1. Begin reviewing and reprocessing Claimant's son's eligibility for Disabled Adult Child (DAC) MA coverage as of October 1, 2012, ongoing;
- 2. Provide the son with MA coverage he is eligible to receive from October 1, 2012, ongoing; and
- 3. Notify Claimant in writing of the Department's decision in accordance with

Department policy.
