HEARING DECISION

This matter is before the undersigned Administ rative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant 's request for a hearing. After due notice, a telephone hearing was held on January 17, 2013. The claimant appeared and testified. FIS, appeared on behalf of the Department.

ISSUE

Whether the Department correctly sanc tioned and closed the Claimant's cash assistance (FIP) for non-compliance with work-related activities without good cause.

FINDINGS OF FACT

The Administrative Law Judge, based on t he competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Claimant was an ongoing recipient of FIP benefits.
- 2. The Claimant was assigned to attend Work First on 7/19/12.
- 3. The Claimant appeared for orientation but did not stay due to lack of day care.
- 4. The Department sent t he Claimant a Notice of Non-Complianc e on 6/27/ 12 indicating that the Claimant did not m eet her participation requirements on 6/03/12. Exhibit 2
- 5. The Notice of Non-Compliance scheduled a triage for 7/5/12.
- 6. The Claimant's FIP grant was only \$38 and the Depa rtment was aware Claimant was working. The Claimant did not attend the triage.

- 7. The Claimant testified that she was working for 40 hours per week.
- 8. The Department did not provide any details of the triage.
- 9. On 8/1/12 the D epartment closed the Claimant's FIP case and imposed a 3-month sanction for non-compliance with Work First participation without good cause. The Notice of Case Action was dated 7/6/12.
- 10. No Depart ment representative or Work First representative that attended the triage attended the hearing.
- 11. The Claimant requested a hearing on 10 /16/12 protesting the closure of her FIP cash assistance case.

CONCLUSIONS OF LAW

The Family Independence Program ("FIP") was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 8 USC 60 1, *et seq.* The Department of Human Services ("D HS" or "Department"), formerly known as the Family Independence Agency, administers the FIP program pursuant to MCL 400.10, *et seq* and Michigan Administrative Code Rules 400.3101-3131. Department policies are found in the Bridges Administrative Manual ("BAM"), the Bridges Eligibility Manual ("BEM"), and the Bridges Reference Manual ("BRM").

DHS requires clients to participat e in employment and self-sufficiency related activities and to ac cept employment when offered. BEM 233A All Work E ligible Individuals ("WEI") as a condition of e ligibility must engage in employment and/or self-sufficiency related activities. BEM 233A The WEI is consid ered non-c ompliant f or failing or refusing to appear and participate with the Jobs, Education, and Training Program ("JET") or other employment service provider. BEM 233A Good cause is a valid reas on for noncompliance with employment and/or self-sufficiency related activities that are based on factors that are beyond the control of the noncompliant person. BEM 233A Failure to comply without good c ause results in FIP closure. BEM 233A T he first and second oc currences of non-compliance r esults in a 3 month FIP closur e. BEM 233A The third occurrence results in a 12 month sanction.

JET participants will not be terminated from a JET program without first scheduling a triage meeting with the client to jointly discuss noncompliance and good cause. BEM 233A In processing a FIP cl osure, the Department is r equired to send the client a notice of non-compliance, DH S-2444, which must include the date(s) of the non-compliance; the reason the client was determined to be non-compliant; and the penalty duration. BEM 233A In addit ion, a triage must be hel d within the negative action period. BEM 233A A good cause e determination is made during the triage and prior to

the negative action effective date. BEM 233A. However, a failure to participate can be overcome if the client has good cause. Good cause is a valid reason for failing to participate with employment and/or self-sufficiency-related activities that are based on factors that are beyond the control of the claimant . BEM 233A. The penalty for noncompliance is FIP closure. Ho wever, a failure to participate can be overcome if the client h as good cause. Good c ause is a valid reason for failing to participate with employment and/or s elf-sufficiency-related activities that are base ed on factors that are beyond the control of the claimant. BEM 2 33A. The penalty for noncompliance is FIP closure. BEM 2 33A. The penalty for noncompliance is FIP closure. BEM 233A provides dir ection to the Department as follows when determining good cause:

Determine good caus e based on the best information available during the triage and prior to the negative action date. Good cause may be verified by information already on file with DHS or the work participation program.

In this case, the Claimant credibly testified that she reported to the Department that she was working 40 hours per week at the time she was assigned to attend the Work First program. She testified that she advis ed her worker that she could not attend the orientation on 5/29/12 as she was scheduled to work. Her worker did not respond to the Claimant. The Claimant also credibly testified that she provided check stubs to the Department and her caseworker. The Department did not have the Claimant's case file at the hearing. The Claimant did not attend the triage bec ause she did not receive the Notice of Non-Compliance until after the triage.

Because the Claimant's testimony was credible and no testimony to the contrary was provided by the Department, the Department ent did not establish a bas is for non-compliance with the Work First and a basis for the imposition of the sanction.

Therefore it is determined that the Department did not meet its burden of proof that it properly closed the Claimant's F IP case for failu re to participate in Work First activities in accordance with Department policy. On t he basis of this testim ony it is found that there was no basis for the sanction that was imposed.

No one from the Work First program or Department who att ended the triage attended the hearing and thus Claimant's credible testimony was unrebutted.

After reviewing the documents submitted at the hearing and the testimony of the parties provided under oath, it is determined that the Depar tment did not meet its burden of proof to demonstrate that it correctly determined that the Claimant failed in her Wor k First participation requirements or failed to demonstrate a basis for the finding of no good cause was established.

Based of the above Findings of Fact and Conclusions of Law and the testimony of witnesses and the documentary evidence admitted, the Department has not

demonstrated that it correctly followed and applied Departm ent policy in closing and sanctioning the Claimant's FIP case fo r non-compliance without good cause and imposing a 3 month sanction. BEM 233A.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, finds t hat the Departm ent incorrectly closed the Cla imant's cash assistance FIP case, and improperly imposed a 3 month sancti on closing the Claimant's case for noncompliance with work-related activities for non-participation with the Work First program. Accordingly, the Department's determination is REVERSED.

Accordingly it is ordered:

- 1. The Department shall initiate reinstatement of the Claimant's FIP case retroactive to the date of closure (8/1/12).
- 2. The Department shall s upplement the Claim ant for FIP benefits, if any, she was otherwise entitled to receive in accordance with Department policy.
- 3. The Department shall remove from its records and the Claimant's case file the 3 month sanction it imposed on the Claim ant for non-compliance with work-related activities.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration MAY be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
