## HEARING DECISION

This matter is before the undersigned Administ rative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claim ant's request for a hearing. After due notice, a telephone hearing was held on January 9, 2013 from Lans ing, Michigan. ### <u>ISSUE</u>

Did the Department properly reduce the Claimant's benefit s for the Food Assistance Program (FAP)?

# FINDINGS OF FACT

I find as material fact, based on the compet ent, material, and substantial ev idence on the whole record:

- Claimant □ applied for benefits for: □ receiv ed benefit s for: □ Family I ndependence Program (FIP). □ Adult Medical Assistance (AMP). □ Food Assistance Program (FAP). □ State Disa bility Assistance (SDA) □ Medical As sistance (MA). □ Child Deve lopment and Care (CDC).
  - 2. On November 19, 2012, the Department sent the Claimant a notice of case action. The notice of case action indicated the Department was reducing the Claimant's FAP benefits due to excess income.
  - 3. On November 28, 2012, the Claim ant requested a hearing to dis pute the FAP benefit reduction.

## CONCLUSIONS OF LAW

Department policies are contained in the Br idges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The FAP [formerly known as the Food Stamp (F S) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in T itle 7 of t he Code of Federal Regulations (CF R). The Department (formerly known as the Fa mily Independence Agenc y) admin isters FAP pursuant to MCL 400.10, *et seq.*, and 1999 AC, R 400.3001 through Rule 400.3015.

In this case, the Department failed to provide t he testimony to show how the Department arrived at a monthly unearned inco me amount of **Sector** Therefore, I was unable to determine whether the Department acted in accordance with the applicable laws and policies in reducing the Claimant's FAP benefits.

Based upon the abov e Findings of Fact and Conclus ions of Law, and for the reasons stated on the record, I conclude the Department improperly reduced the Claimant's FAP benefits.

# DECISION AND ORDER

I find based upon the above F indings of Fa ct and Conclusions of Law, and for the reasons stated on the record, the Department did not act properly.

Accordingly, the Dep artment's FAP decis ion is **REVERSED** for the reasons stated on the record.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Initiate a redetermination as to t he Claimant's eligibility for FAP benefits beginning December 1, 2012 and iss ue retroactive benefits if otherwis e qualified and eligible.

**NOTICE**: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a par ty within 30 days of the mailing date of this Dec ision and Order . MAHS will not or der a rehearing or reconsideration on the Department's mo tion where the final decis ion cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing MAY be granted if there is newly disc overed evidence that could affect the outcome of the original hearing decision.
- A reconsideration MAY be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error r, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address ot her relevant iss ues in the hearing decision.
