FINDINGS OF FACT		
The Administrative Law Judge, based upon	the competent, materia	al. and substantia

The Administrative Law Judge, based upon the competent, material, and substantia evidence on the whole record, including testimony of witnesses, finds as material fact:

- 1. Claimant was receiving FAP benefits.
- 2. On November 20, 2012, the Departm ent sent the Claimant a verification checklist. The checklist was due November 30, 2012.
- 3. As of Nov ember 30, 2012, the Claiman thad not returned a single verification.

- 4. On December 3, 2012, the Department sent the Claimant a notice of case action. T he notice indicated the Claimant's FAP benefits were closin g January 1, 2013.
- 5. On December 10, 2012, the Claimant requested a hearing.

CONCLUSIONS OF LAW

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The FAP [formerly known as the Food Stamp (F S) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in T itle 7 of the Code of Federal Regulations (CF R). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, et seq., and 1999 AC, R 400.3001 through Rule 400.3015.

Clients must cooperate with the local office in determining initial and ongoing eligibility. This includes completion of necessary forms. Client's must completely and truthfully answer all questions on forms and in interviews.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the c lient at least 10 days (or other timeframe specified in policy) to obtain the needed information.

Testimony and other evidence must be we ighed and considered according to its reasonableness. Moreover, the weight and credibility of this evidence is generally for the fact-finder to determine. In evaluating the credibility and weight to be given the testimony of a witness, the fact-finder may consider the demeanor of the witness, the reasonableness of the witness is testimony, and the interest, if any, the witness may have in the outcome of the matter.

I have carefully considered and weighed the testimony and other evidence in the record and find the Claimant never returned the requested verifications as requested a nd required. Furthermore, the Claimant lacked a good cause reason as to why she failed to return the requested verifications.

Accordingly, I **AFFIRM** the Department's actions in this matter.

(60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address ot her relevant iss ues in the hearing decision.
