FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On an unknown date, the Department:

denied Claimant's application for benefits
closed Claimant's case for benefits
reduced Claimant's benefits

under the following program(s):

2. On no date, the Department sent notice to Claimant (or Claimant's Authorized Hearing Representative) of the:

3. On December 10, 2012, Claimant filed a request for hearing concerning the Department's action.

CONCLUSIONS OF LAW

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), the Reference Tables Manual (RFT), and the State Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: designate Claimant to be in compliance with the Office of Child Support as of May 2, 2013, and determine eligibility for MA benefits.

As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO INITIATE THE FOLLOWING ACTION WITHIN TEN (10) DAYS OF THE MAILING DATE OF THIS ORDER:

- 1. Designate Claimant to be in compliance with the Office of Child Support effective May 2, 2013.
- 2. Determine Claimant's eligibility for MA benefits.
- 3. Provide retroactive and ongoing MA benefits at the benefit level and date that Claimant is entitled to them.
