HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on February 14, 2013, from Detroit, Michigan. Participants on behalf of Claimant included Claimant and Participants on behalf of the Department of Human Services (Department) included Eligibility Specialist, and Eligibility Specialist.

<u>ISSUE</u>

Did the Department properly calculate Claimant's Food Assistance Program (FAP) benefits for January 1, 2013, ongoing?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Claimant was an ongoing recipient of FAP benefits.
- In connection with a January 2013 increase in Claimant's benefits from Supplemental Security Insurance (SSI), the Department recalculated Claimant's FAP budget.
- 3. On December 8, 2012, the Department sent Claimant a Notice of Case Action advising him that his monthly FAP benefits would be reduced to \$114 effective January 1, 2013.

4. On January 8, 2013, Claimant filed a request for hearing, disputing the Department's calculation of his FAP benefits.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).
☐ The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 42 USC 601, et seq. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10, et seq., and Mich Admin Code, R 400.3101 through R 400.3131. FIP replaced the Aid to Dependent Children (ADC) program effective October 1, 1996.
∑ The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, <i>et seq.</i> , and Mich Admin Code, R 400.3001 through R 400.3015.
☐ The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105.
☐ The Adult Medical Program (AMP) is established by 42 USC 1315, and is administered by the Department pursuant to MCL 400.10, et seq.
☐ The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, is established by 2004 PA 344. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, <i>et seq.</i> , and Mich Admin Code, R 400.3151 through R 400.3180.
☐ The Child Development and Care (CDC) program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department provides services to adults and children pursuant to MCL 400.14(1) and Mich Admin Code, R 400.5001 through R 400.5015.

Additionally, the December 8, 2012 Notice of Case Action sent to Claimant notified him that his monthly FAP benefits would be reduced to \$114, beginning January 1, 2013.

At the hearing, the Department testified that Claimant's decreased FAP benefits were due to an increase in his SSI benefits. The Department produced a FAP budget showing the calculation of Claimant's monthly FAP benefits for January 1, 2013, ongoing. Claimant verified that he received monthly SSI benefits of \$710 beginning January 1, 2013, and monthly State SSI Payment (SSP) benefits of \$14 (based on quarterly payments of \$42). He also verified that he was the sole member of his FAP group. A review of the FAP budget and the Notice of Case Action shows that the Department properly applied the \$148 standard deduction applicable to his FAP group size of one and the \$575 standard heat and utility deduction available to all FAP recipients. RFT 255 (October 1, 2012), p 1; BEM 554 (October 1, 2012), pp 11-12.

In calculating Claimant's excess shelter deduction, the Department testified that it did not consider any housing expenses because Claimant had failed to verify such expenses. See BEM 554, p 11. However, the Notice of Case Action shows that the Department considered monthly housing expenses of \$3.93. Therefore, this figure is considered in recalculating Claimant's FAP budget. While Claimant indicated that he had brought additional documentation concerning his housing expenses to the hearing which was not previously provided, the Department is required to consider these expenses in accordance with Department policy to affect *future* FAP budgets. See BAM 220 (November 1, 2012), p 8.

A review of the FAP budget based on the information before the Department prior to the January 1, 2013 effective date of the FAP benefit decrease shows that the Department acted in accordance with Department policy when it concluded that Claimant had monthly net income of \$285 and was eligible for monthly FAP benefits of \$114, effective January 1, 2013. BEM 556 (October 1, 2011); RFT 260 (December 1, 2012), p 9.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions
of Law, and for the reasons stated on the record, finds that the Department
☑ did act properly when calculating Claimant's FAP budget.
did not act properly when .
Accordingly, the Department's decision is \boxtimes AFFIRMED \square REVERSED for the
reasons stated on the record and above.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome
 of the original hearing decision.
- A reconsideration <u>MAY</u> be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
