HEARING DECISION

This matter is before the undersigned Admini strative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claim ant's request for a hearing. After due notice, a telephone hearing was held on February 13, 2013, from Lansing, Michigan. The Department did not call Participants on behalf of Claimant included in for the hearing and I proceeded in the absence of this party.

ISSUE

Did the Department pr operly close the Claimant's F AP case beginning J anuary 1, 2013?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantia evidence on the whole record, including testimony of witnesses, finds as material fact:

- 1. As of December 31, 2012, the Claimant was receiving FAP benefits.
- 2. On January 1, 2013, the Department closed the Claimant's FAP case.
- 3. On January 10, 2013, the Claimant requested a hearing.

CONCLUSIONS OF LAW

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The FAP [formerly known as the Food Stamp (F S) program] is established by the Food Stamp Act of 1977, as amended, and is impl emented by the federal regulations contained in T itle 7 of t he Code of Federal Regulations (CF R). The Department (formerly known as the Fa mily Independence Agenc y) admin isters FAP pursuant to MCL 400.10, et seq., and 1999 AC, R 400.3001 through Rule 400.3015.

Clients have the right to contest a Departm ent decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. The Department will provide an administrative hearing to rev iew the decision and determine the appropriateness of that decision. (BAM 600).

The local office and client or authorized h earing representative will each present their position to the ALJ, who will determine whether the actions taken by the local office are correct according to fact, law, policy and procedure. In most cases, the client or authorized hearing repres entative and loc al office staff will be together in the hearing room and will speak into a speaker telephone. The ALJ will be on the other end of the phone line. Following the opening statement(s), if any, the ALJ directs the DHS cas e presenter to explain the position of the local office. The hearing summary, or highlights of it, may be read into the record at this time. The hearing summary may be used as a guide in presenting the evidenc e, witnesses and exhibits that support the Department's position. Always include the following in planning the case presentation. (BAM 600).

In this case, the Department did not appear and did not provide testimony regarding the actions taken regarding the Claimant's FAP case. Therefore I was unable to determine whether or not the Department acted in conformity with the applicable laws and policies when they closed the Claimant's FAP case on January 1, 2013. Based upon this fact, I find the Department im properly closed the Claimant's FAP c ase beginning January 1, 2013.

DECISION AND ORDER

I find, bas ed upon the above Findings of Fa ct and Conclusions of Law, and for the reasons stated on the record, find the Department did not act properly in this matter.

Accordingly, the Department's decision is **REVERSED**.

The Department is ordered to:

1. Initiate a redetermination as to t he Claimant's eligibi lity for FAP benefits beginning January 1, 2013 and issue retroac tive benefits if otherwise eligible and qualified.

NOTICE: Michigan Administrative Hearing Syst em (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the receipt date of this Dec ision and Orde r. MAHS will not or der a rehearing or reconsideration on the Department's mo tion where the final decis ion cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration <u>MAY</u> be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, math ematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address other relevant issues in the hearing decision.
