### SETTLEMENT ORDER

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on May 16, 2013, from Detroit, Michigan. Participants on behalf of Claimant included Claimant's Authorized Hearing Representative, Participants on behalf of the Department of Human Services (Department) included , MCW. **ISSUE** Whether the Department properly: denied Claimant's application for benefits closed Claimant's case for benefits reduced Claimant's benefits for: Family Independence Program (FIP)? State Disability Assistance (SDA)? Food Assistance Program (FAP)? Child Development and Care (CDC)? Medical Assistance (MA)? State Emergency Services (SER)? Adult Medical Assistance (AMP)?

### **FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On January 16, 2013, Claimant filed a request for hearing concerning the Department's action with respect to MA.
- 2. During the hearing, the parties reached an agreement whereby the Department would reprocess Claimant's MA application of January 13, 2011, retroactive to November of 2010.

# **CONCLUSIONS OF LAW**

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), the Reference Tables Manual (RFT), and the State Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: reprocess Claimant's MA application of January 13, 2011, retroactive to November of 2010.

As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

# **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT SHALL BEGIN TO INITIATE THE FOLLOWING STEPS WITHIN TEN DAYS OF THE MAILING OF THIS ORDER:

1. Initiate reprocessing of Claimant's MA application of January 13, 2011, retroactive to November of 2010.

2. Issue a written notice of eligibility determination to Claimant's Authorized Hearing Representative.
