# FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On January 15, 2013, the Department:

denied Claimant's application for benefits
closed Claimant's case for benefits

reduced Claimant's benefits

under the following program(s):

## CONCLUSIONS OF LAW

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), the Reference Tables Manual (RFT), and the State Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, *et seq.*, and 1999 AC, Rule 400.3001 through Rule 400.3015.

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: determine eligibility for Medicaid and provide appropriate Medicaid benefits to Claimant. As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

In addition, this case concerns the denial of FAP benefits. Shortly after the commencement of the hearing, Claimant testified she now understood and accepted the actions taken by the Department regarding FAP benefits. Claimant also testified that s/he did not wish to proceed with a hearing on the issue of FAP benefits. The Department agreed to the dismissal of Claimant's hearing request. Pursuant to Michigan Administrative Code Rule (MAC R 400.906(1)), Claimant's hearing request is hereby DISMISSED as to FAP benefits only.

#### DECISION AND ORDER

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT SHALL INITIATE WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER, THE FOLLOWING:

- 1. Process Claimant's Medicaid application of January 24, 2013.
- 2. Provide retroactive and ongoing Medicaid benefits to Claimant at the benefit level to which she is entitled.
- 3. All steps shall be taken in accordance with Department policy and procedure.

IT IS FURTHER ORDERED THAT based on the above discussion, it is ORDERED that the issue of FAP benefits is DISMISSED from this case pursuant to MAC R 400.906(1).
