# **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claim ant's request for a hearing. # <u>ISSUE</u>

Did the Department properly reduce the Claimant's F ood Assistance Program (FAP) allotment?

### FINDINGS OF FACT

I find as material fact, based on the compet ent, material, and substantial evidence on the whole record:

- 1. As of December 2012, the Claimant received FAP benefits.
- 2. On January 1, 2013, the De partment reduced the Claiman t's FAP benefits.
- On December 12, 2012, the Clai mant requested a hearing regar ding the reduction of her FAP benefits

## CONCLUSIONS OF LAW

Department policies are contained in the Br idges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The FAP [formerly known as the Food Stamp (F S) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in T itle 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, et seq., and 1999 AC, R 400.3001 through Rule 400.3015.

In this case, the Department failed to provi de testimony or exhibits to show how the Department calculated the r educed FAP allotment. Specifically, the Department was missing evidence and testimony regarding the specific determinations regarding both earned and unearned income. Therefore, I was unable to determine whether the Department acted in accordance with the applicable laws and policies in reducing the Claimant's FAP allotment.

Based upon the abov e Findings of Fact and Conclus ions of Law, and for the reasons stated on the record, I conclude the Department improperly reduced the Claimant's FAP allotment.

# **DECISION AND ORDER**

I find based upon the above F indings of Fa ct and Conclusions of Law, and for the reasons stated on the record, the Department did not act properly.

Accordingly, the Dep artment's FAP decis ion is **REVERSED** for the reasons stated on the record.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Initiate a redetermination as to the Claimant's eligibility for FAP benefits beginning January 1, 2013 and issue retroactive benefits if otherwise qualified and eligible.

**NOTICE**: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a par ty within 30 days of the mailing date of this Dec ision and Order. MAHS will not or der a rehearing or reconsideration on the Department's mo tion where the final decis ion cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing MAY be granted if there is newly disc overed evidence that could affect the outcome of the original hearing decision.
- A reconsideration MAY be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
- the failure of the ALJ to address ot her relevant iss ues in the hearing decision.
