In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: accept documentation of claimant's rent and other expenses that are part of the claimant's FAP come putation, recalculate, and supplement for any missed benefits..

As a result of this settlement, Claimant no longer wish es to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

1. Accept documentation of claimant's r ent and other expenses that are part of the claimant's FAP computation, recalculate, and supplement for any missed benefits.
