Department of Human Services (formerly known as the Family Independence by) administers the MA program pursuant to MCL 400.10, et seq., and MCL 05.
	aw provides that disposition may be made of a contested case by stipulation or d settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: reinstate Claimant's August 30, 2012 MA and MA-retroactive application, and process the application for June, 2012, the month in which she was deceased, and all other months allowable pursuant to Department policy and procedure..

As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

## **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO INITIATE THE FOLLOWING ACTION WITHIN TEN DAYS OF THE MAILING DATE OF THIS ORDER:

- 1. Reinstate Claimant's August 30, 2012 MA and MA-retroactive application.
- 2. Determine eligibility for June, 2012, the month in which she passed away, and all other appropriate months of MA coverage.
- 3. All steps shall be taken in accordance with Department policy and procedure.
