# **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claim ant's request for a hearing. After due notice, a telephone hearing was held on April 3, 2013 from Lansi ng, Michigan. Participants on behalf of Claimant included Participants on behalf of the Department of Human Services (Department) included

### <u>ISSUE</u>

Whether the Department properly closed t he Claim ant's Food Assistanc e Program (FAP) benefits due to a criminal justice disqualification?

#### FINDINGS OF FACT

I find as material fact, based upon the competent, material and substantial evidence on the whole record:

- 1. As of February 10, 2013, the Claimant was receiving FAP benefits.
- On February 11, 2013, the Department sent the Claimant a notice of case action.
   The notic e indicated the Cl aimant's FAP benefits wer e being c losed effective March 1, 2013 due to a criminal justice disqualification.
- 3. On March 4, 2013, the Claimant requested a hearing.
- 4. At no point in time in Februar y of 2013 was the Claimant a fugitive felon, probation violator or parole violator.

# **CONCLUSIONS OF LAW**

Department policies are contained in the Br idges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).

The FAP [formerly known as the Food Stamp (F S) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations

contained in T itle 7 of t he Code of Federal Regulations (CF R). The Department (formerly known as the Fa mily Independence Agenc y) admin isters FAP pursuant to MCL 400.10, *et seq.*, and 1999 AC, R 400.3001 through Rule 400.3015.

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, MAC R 400.901-400.951. An oppor tunity for a hearing shall be granted to an ap plicant who requests a hearing because his claim for assistance is denied. MAC R 400.903(1).

Clients have the right to c ontest a department decis ion affe cting eligibil ity or benefit levels whenever it is belie ved that the decision is inco rrect. BAM 600. The department will provide an adm inistrative hearing to review the decision and determine the appropriateness. BAM 600.

People convicted of certain crimes, fugitive felons, and probation or parole violators are not eligible for assistance. (BEM 203).

However, in this matter, the Department di d not present any evidence to indicate the Claimant met one of the disqualification criteria listed in BEM 203.

Because the Department failed to provide any evidence of the Claimant meeting one of the disqualification criteria, I am reversing the Department in this matter.

# **DECISION AND ORDER**

I find, bas ed upon the above Findings of Fa ct and Conclusions of Law, and for the reasons stated on the record, the Department did not act properly.

Accordingly, the Department's FAP decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Initiate a redetermination as to t he Claimant's eligible lity for FAP benefits beginning March 1, 2013 and is sue retroactive benefits if otherwise eligible and qualified.

**NOTICE**: Administrative Hearings may or der a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. Administrative Hear ings will not orde rarehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the mailing of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration <u>MAY</u> be granted for any of the following reasons:
  - misapplication of manual policy or law in the hearing decision,
  - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
  - the failure of the ALJ to address other relevant issues in the hearing decision.
