**SETTLEMENT ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was conducted on Wednesday, June 12, 2013, from Detroit, Michigan on behalf of Claimant was [REDACTED] ([REDACTED]). Participant on behalf of the Department of Human Services (Department) was [REDACTED] (Eligibility Specialist).

**ISSUE**

Whether the Department properly processed the Claimant's Medical Assistance (MA) application?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On March 28, 2012, the Department received an application for Medicaid with request for retro MA to January 2012 from [REDACTED] as Authorized Hearing Representative (AHR) on behalf of the Claimant.
2. The Claimant was approved for SSI benefits based on disability.
3. On March 1, 2013, the Department received a written hearing request from [REDACTED] on behalf of Claimant concerning the processing of the MA coverage for the months in question.

4. On March 7, 2013, the Department provided Claimant full MA coverage on the system effective as of January 2012 but missed several months of full MA coverage.
5. At hearing the parties reached a settlement agreement.

### **CONCLUSIONS OF LAW**

The Department of Human Services (DHS) policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), the Reference Tables Manual (RFT), and the State Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2). In the present case, L & S requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: to process the Claimant for full MA coverage on the system for any months not fully covered as of January 2012 specifically March 2012 & April 2012.

As a result of this settlement, the AHR no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.


### **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

1. The Department shall provide the Claimant with full MA coverage for March & April 2012, and any other months not fully covered as of January 2012, if Claimant is otherwise eligible and qualified.

2. The Department shall provide in writing L& S (AHR) notice of case action regarding the MA coverage for the period in question.
