# **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request fo ra hearing. After due notice, an inperson hearing was held on May 15, 2013, at the Berrien County DHS office. Claimant personally appeared and testified. Participants on behalf of Department of Human Services (Department) included Assistance Payment Supervisor

# ISSUE

Whether the Department proper ly closed Claimant's case for the Food Assistanc e Program (FAP) bas ed on more than one drug-related felony conviction occurring after 8/22/96?

# FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantia I evidence on the whole record, including testimony of witnesses, finds as material fact:

- 1. Claimant was receiving FAP benefits at the time of the hearing.
- 2. On March 6, 2013, the Department sent notice of the closure of Claimant's case.
- 3. Effective April 1, 2013, the Department closed Claima nt's FAP c ase for having two felony drug convictions after 8/22/96.
- 4. On March 6, 2013, Claimant filed a hearing request, protesting the closure reduction.

## **CONCLUSIONS OF LAW**

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amend ed, and is implemented by the

federal regulations contained in Title 7 of the Code of Feder al Regulations (CFR). The Department (formerly known as the Fam ily Independence Agency) administers FAP pursuant to MCL 400.10, *et seq.*, and 1997 AACS R 400.3001-3015

Additionally, Claimant admitted during the hearing to the two felony drug convictions.

Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department properly closed Claimant's case.

# **DECISION AND ORDER**

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the reco rd, finds that the Department did act properly.

Accordingly, the Depar tment's decision is **AFFIRMED** for the reasons stated on the record.

It is SO ORDERED.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the mailing of the Decision and Order or, if a ti mely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
- misapplication of manual policy or law in the hearing decision,
- typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant;
- the failure of the ALJ to address other relevant issues in the hearing decision
