**SETTLEMENT ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on May 8, 2013, from Detroit, Michigan. Claimant appeared and testified. Participants on behalf of the Department of Human Services (Department) included [REDACTED].

**ISSUE**

Whether the Department properly:

- denied Claimant's application for benefits
- closed Claimant's case for benefits
- reduced Claimant's benefits

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On April 1, 2013, the Department

- denied Claimant's application for benefits
- closed Claimant's case for benefits
- reduced Claimant's benefits

under the following program(s):

- FIP
- FAP
- MA
- AMP
- SDA
- CDC
- SER.

2. On March 29, 2013, the Department sent notice to Claimant (or Claimant's Authorized Hearing Representative) of the

- denial
- closure
- reduction.

3. On April 9, 2013, Claimant filed a request for hearing concerning the Department's action.

### **CONCLUSIONS OF LAW**

Department policies are found in the Department of Human Services Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), Reference Tables Manual (RFT), and State Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, *et seq.*, and Mich Admin Code, R 400.3001 through R 400.3015.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant's FAP benefits were recalculated in connection with a redetermination. The Department sent Claimant a Notice of Case Action informing her of the amount of FAP benefits she was eligible to receive. Claimant disputed this amount and requested a hearing. Exhibit 1, pp. 12-13. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. At the hearing, the Department acknowledged that there were errors in the calculation of Claimant's income and consequently, the Department agreed to do the following: (i) begin recalculating the FAP budget from April 1, 2013, ongoing in accordance with Department policy; (ii) begin issuing supplements to Claimant for any FAP benefits that she was eligible to receive but did not from April 1, 2013, ongoing in

accordance with Department policy; and (iii) notify Claimant of its decision in writing in accordance with Department policy.


As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

**DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

1. Begin recalculating the FAP budget from April 1, 2013, ongoing in accordance with Department policy;
2. Begin issuing supplements to Claimant for any FAP benefits that she was eligible to receive but did not from April 1, 2013, ongoing in accordance with Department policy; and
3. Notify Claimant of its decision in writing in accordance with Department policy.
