HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on May 16, 2013, from Detroit, Michigan. Participants included the above-named Claimant. Participants on behalf of Department of Human Services (DHS) included [REDACTED], Specialist.

ISSUE

The issue is whether DHS properly determined Claimant's eligibility for Food Assistance Program (FAP) benefits.

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant was an ongoing FAP benefit recipient.
2. Claimant was part of a household of three persons.
3. Claimant received gross employment income of \$460.56 on [REDACTED] and \$517.26 on [REDACTED] (see Exhibit 6)
4. Claimant's household also received \$551/month in Retirement, Survivors, Disability Insurance (RSDI) and child support.
5. Claimant's household had no child care, day care or medical expenses.

6. Claimant had a rent of \$575/month.
7. On 3/29/13, DHS determined Claimant to be eligible for \$274/month in FAP benefits, effective 4/2013 (see Exhibits 3-5).
8. On 4/15/13, Claimant requested a hearing to dispute the FAP benefit determination.

CONCLUSIONS OF LAW

The Food Assistance Program (formerly known as the Food Stamp Program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). DHS administers the FAP pursuant to Michigan Compiled Laws 400.10, *et seq.*, and Michigan Administrative Code R 400.3001-3015. DHS regulations are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The present case also concerns a FAP benefit eligibility determination. BEM 556 outlines the proper procedures for calculating FAP benefit eligibility.

It was not disputed that Claimant received biweekly gross employment income. In determining Claimant's prospective income, DHS relied on Claimant's most recent submitted pay verifications, from [REDACTED] and [REDACTED]. Claimant testified that her pays have since decreased, but admitted that she did not report reduced pays to DHS prior to 3/29/13, the date of the DHS determination. Claimant's reported income reduction may be relevant to DHS action and/or inaction after 3/29/13, but do not impact the correctness of DHS actions from 3/29/13. As of 3/29/13, DHS properly relied on Claimant's pay verifications from [REDACTED] and [REDACTED] as proof Claimant's income.

DHS converts bi-weekly non-child support income into a 30 day period by multiplying the income by 2.15. BEM 505 (10/2010), p. 6. Multiplying Claimant's bi-weekly income by 2.15 results in a monthly employment income of \$1051, the same amount calculated by DHS.

DHS counts 80% of a FAP member's timely reported monthly gross employment income in determining FAP benefits. Applying the 20% deduction to the employment income creates a countable monthly employment income of \$840 (dropping cents). Adding the countable employment income to Claimant's unearned income (\$551) results in a running countable income of \$1391.

DHS uses certain expenses to determine net income for FAP eligibility and benefit levels. BEM 554 (11/2012), p. 1. For groups without a senior (over 60 years old), disabled or disabled veteran (SDV) member, DHS considers the following expenses: child care, excess shelter (housing and utilities) up to a capped amount and court-ordered child support and arrearages paid to non-household members. For groups

containing SDV members, DHS also considers the medical expenses for the SDV group member(s) and an uncapped excess shelter expense.

Claimant alleged that she was disabled because of a loss of visual acuity. For purposes of FAP benefits, a “disability” requires a determination of disability by Social Security Administration (SSA) or DHS. BEM 550 (2/2012), p. 1. It was not disputed that Claimant was not deemed disabled by SSA or DHS. Accordingly, Claimant is not disabled for purposes of FAP benefit eligibility.

Verified medical expenses for SDV groups, child support and day care expenses are subtracted from a client’s monthly countable income. DHS applies a \$35/month copayment to monthly medical expenses. It was not disputed that Claimant had no such expenses.

Claimant’s FAP benefit group receives a standard deduction of \$148. RFT 255 (10/2012), p. 1. The standard deduction is given to all FAP benefit groups, though the amount varies based on the benefit group size. The standard deduction is also subtracted from the countable monthly income to calculate the group’s adjusted gross income. The adjusted gross income amount is found to be \$1243.

It was not disputed that Claimant verified a \$450/month rent obligation. DHS gives a flat utility standard to all clients. BEM 554 (1/2011), pp. 11-12. The utility standard of \$575 (see RFT 255 (10/2012, p. 1) encompasses all utilities (water, gas, electric, telephone) and is unchanged, even if a client’s monthly utility expenses exceed the \$575 amount. The total shelter obligation is calculated by adding Claimant’s housing expenses to the utility credit; this amount is found to be \$1025.


DHS only credits FAP benefit groups with what DHS calls an “excess shelter” expense. This expense is calculated by taking Claimant’s total shelter obligation and subtracting half of Claimant’s adjusted gross income. Claimant’s excess shelter amount is found to be \$404.

The FAP benefit group’s net income is determined by taking the group’s adjusted gross income and subtracting the allowable excess shelter expense. The FAP benefit group’s net income is found to be \$839. A chart listed in RFT 260 is used to determine the proper FAP benefit issuance. Based on Claimant’s group size and net income, Claimant’s proper FAP benefit issuance is found to be \$274, the same amount calculated by DHS (see Exhibits 1-2).

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that DHS properly determined Claimant’s eligibility for FAP benefits, effective 4/2013.

The actions taken by DHS are AFFIRMED.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
