HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on June 17, 2013, from Detroit, Michigan. Claimant appeared and testified. Participating on behalf of the Department of Human Services (Department) was ██████████ Assistance Payment Worker.

ISSUE

Did the Department act in accordance with Department policy when it terminated Claimant's Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant was an ongoing recipient of FAP benefits.
2. On May 6, 2013 the Department sent Claimant a Notice of Case Action informing her that her FAP case would be closing effective June 1, 2013 for failure to verify requested information. (Exhibit 1)
3. On May 15, 2013, Claimant filed a request for hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are found in the Department of Human Services Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), Reference Tables Manual (RFT), and State Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, et seq., and Mich Admin Code, R 400.3001 through R 400.3015.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant was an ongoing recipient of FAP benefits. On April 22, 2013, the Department sent Claimant an Unearned Income Notice informing her that the Department would be contacting her to verify and provide proofs for unearned income that was reported to the Department. On an unverified date, the Department sent Claimant a redetermination that was to be completed and returned to the Department. On May 6, 2013, the Department sent Claimant a Notice of Case Action informing her that her FAP case would be closing effective June 1, 2013 for failure to verify requested information. (Exhibit 1). Claimant requested a hearing to dispute the closure. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: (i) initiate reinstatement of Claimant's FAP case effective June 1, 2013 in accordance with Department policy; (ii) begin reprocessing Claimant's FAP redetermination; (iii) recalculate the FAP budget from June 1, 2013 ongoing in accordance with Department policy; (iv) begin issuing supplements to Claimant for any FAP benefits that she was entitled to receive but did not from June 1, 2013; and (v) notify Claimant of its decision in writing in accordance with Department policy.


As a result of this settlement, Claimant no longer wishes to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing with regards to FAP.

THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

1. Initiate reinstatement of Claimant's FAP case effective June 1, 2013 in accordance with Department policy;
2. Begin reprocessing Claimant's FAP redetermination;
3. Recalculate the FAP budget from June 1, 2013 ongoing in accordance with Department policy;
4. Begin issuing supplements to Claimant for any FAP benefits that she was entitled to receive but did not from June 1, 2013; and
5. Notify Claimant of its decision in writing in accordance with Department policy.

NOTICE: Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
