Additionally, the Claim ant test ified that she did receive t he Wage Match Client Notice but it was misplaced in her home and was not returned by the due date. Exhibit 1. Based upon these facts, the Department properly closed the Claimant's Food Assistance case as it did not receive the requested verification by the due date. Bridges Administrative Manual (BAM) 130 (12/2012).

The Claimant may reapply for food assistance at any time.

Based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, the Administrative Law Judge concludes that the Department properly improperly

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing <u>MAY</u> be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration <u>MAY</u> be granted for any of the following reasons:
 - misapplication of manual policy or law in the hearing decision,
 - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
 - the failure of the ALJ to address other relevant issues in the hearing decision.
