SETTLEMENT ORDER

The law, MCL 24.278(2); MSA 3.560(178)(2) provides that a disposition may be made of a contested case hearing by stipulation or agreed settlement. In this case a hearing was scheduled for May 8, 2013.

Prior to the beginning of the recorded record Claimant and the Department of Human Services agreed that the Department will re-determine Claimant's Medical Assistance (MA) eligibility from January 1, 2013 on and issue a Notice of Case Action (DHS-1605) documenting the eligibility determination.

Since the claimant and the department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge has determined that the Department of Human Services and Claimant have come to a settlement regarding Claimant's request for hearing in this case. Therefore it is ORDERED that the Department of Human Services re-determine Claimant's Medical Assistance (MA) eligibility from January 1, 2013 on and issue a Notice of Case Action (DHS-1605) documenting the eligibility determination in accordance with this settlement agreement.
