**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was held on July 25, 2013. Claimant personally appeared and testified. Participants on behalf of the department included Lead Worker [REDACTED] and Eligibility Specialist [REDACTED].

**ISSUE**

Did the department properly deny Claimant's Medicaid (MA), Retro-MA and State Disability Assistance (SDA) application based on a finding she lacks a legally disabling condition?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On October 26, 2012, Claimant applied for MA/Retro-MA and SDA based on disability.
2. When the department denied that application, Claimant requested a hearing by written notice dated March 25, 2013.
3. On June 12, 2013, the State Hearing Review Team (SHRT) denied Claimant's MA and SDA application based on Vocational Rule 202.20.
4. Claimant's hearing was held by telephone on July 25, 2013.

5. During the hearing, this Administrative Law Judge received a State Online Query (SOLQ) from the department showing Claimant had received a Fully Favorable decision from the Social Security Administration (SSA) and had been determined disabled, with an onset date established as of April 14, 2012.

### **CONCLUSIONS OF LAW**

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and Mich Admin Code, Rules 400.3151-400.3180. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

In Michigan, the SSA's determination of disability onset is binding for MA eligibility purposes. In the present case, evidence of the favorable SSA decision conclusively establishes Claimant meets the federal standard necessary to qualify for MA pursuant to BEM Items 150 and 260.

Based on the SOLQ showing SSA found that Claimant was disabled with an onset date of April 14, 2012, the only remaining issue is whether Claimant is eligible for Retro-MA. Departmental policy states that Retro-MA coverage is available back to the first day of the third calendar month prior to:

- The current application for FIP and MA applicants and persons applying to be added to the group.
- The most recent application (not redetermination) for FIP and MA recipients. BAM 115


In this case, Claimant applied for MA, Retro-MA and SDA on October 26, 2012. Claimant was found Disabled by SSA with an established onset date of February, 2012. According to departmental policy, "Retro-MA coverage is available back to the first day of the third calendar month prior to the current application for . . . MA." BEM 150. Therefore, based on department policy, this Administrative Law Judge finds Claimant is entitled to Retro-MA back to the first day of the third calendar month prior to her October, 2012 application.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides the department erred in determining Claimant is not disabled.

Accordingly, the department's decision is **REVERSED**, and it is ORDERED that:

1. The department shall approve MA and SDA benefits for Claimant as long as she is otherwise eligible to receive them and Retro-MA back to July, 2012.
2. Departmental review of Claimant's medical condition is not necessary as long as her SSA disability status continues.

**NOTICE:** Administrative Hearings may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. Administrative Hearings will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
  - misapplication of manual policy or law in the hearing decision,

- the failure of the ALJ to address other relevant issues in the hearing decision.
