HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 and in accordance with 7 CFR 273.16 and Mich. Admin Code, Rule 400.3130 upon the Department of Human Services' (Department) request for a hearing. After due notice, a hearing was held on June 27, 2013. Respondent did not appear. The record did not contain returned mail. In accordance with Bridges Administration Manual (BAM) 720 the hearing proceeded without Respondent. The Department was represented by

ISSUE

Whether Respondent committed an Intentional Program Violation (IPV) and whether Respondent received a over-issuance of Medical Assistance (MA) benefits between May 3, 2007 and September 30, 2007 which the Department is entitled to recoup

Whether Respondent committed an Intentional Program Violation (IPV) and whether Respondent received a over-issuance of Food Assistance Program (FAP) benefits between May 3, 2007 and September 1, 2007 which the Department is entitled to recoup?

Whether Respondent received duplicate Food Assistance Program (FAP) benefits in violation of Department of Human Services Bridges Eligibility Manual (BEM) 222 page 2?

FINDINGS OF FACT

The Administrative Law Judge, based upon the clear and convincing evidence on the whole record, finds as material fact:

- (1) On May 3, 2007, Respondent submitted an application for Medical Assistance (MA) and Food Assistance Program (FAP) in Michigan and intentionally failed to report information or gave incomplete or inaccurate information needed to make a correct benefit determination by failing to report that she was already receiving Medical Assistance (MA) and Food Assistance Program (FAP) benefits from Minnesota.
- (2) Respondent was clearly and correctly instructed regarding reporting responsibilities as evidenced by her signature of the assistance application.
- (3) Respondent has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill their reporting responsibilities.
- (4) Respondent committed an Intentional Program Violation (IPV) by: intentionally failing to report that she was already receiving Medical Assistance (MA) and Food Assistance Program (FAP) benefits from Minnesota and by receiving duplicate Food Assistance Program (FAP) benefits from Michigan and Minnesota from May 3, 2007 to September 30, 2007 in violation of Department of Human Services Bridges Eligibility Manual (BEM) 222.
- (5) May 3, 2007 to September 30, 2007 is the correct over-issuance period in this case.
- (6) As a result of the Intentional Program Violation (IPV) Respondent received a over-issuance of Medical Assistance (MA) benefits and a over-issuance of Food Assistance Program (FAP) benefits during the over-issuance period.
- (7) On March 28, 2013, the Office of Inspector General submitted this request for a hearing to disqualify Respondent from receiving Food Assistance Program (FAP) benefits.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) [formerly known as the Food Stamp (FS) program] is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, *et seq.*, and 1997 AACS R 400.3001-3015.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in

the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

In this case, the Department has requested a disqualification hearing to establish an over-issuance of benefits as a result of an Intentional Program Violation (IPV) and the Department has asked that Respondent be disqualified from receiving Food Assistance Program (FAP) benefits. Department policies provide the following guidance and are available on the internet through the Department's website.

BAM 720 INTENTIONAL PROGRAM VIOLATIONS DEPARTMENT POLICY

All Programs

Recoupment policies and procedures vary by program and over-issuance (OI) type. This item explains Intentional Program Violation (IPV) processing and establishment.

BAM 700 explains OI discovery, OI types and standards of promptness. BAM 705 explains agency error and BAM 715 explains client error.

DEFINITIONS

All Programs

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill their reporting responsibilities.

IPV is suspected when there is clear and convincing evidence that the client or CDC provider has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility.

IPV

FIP, SDA and FAP

The client/authorized representative (AR) is determined to have committed an IPV by:

- A court decision.
- An administrative hearing decision.
- The client signing a DHS-826, Request for Waiver of Disqualification Hearing or DHS-830, Disqualification Consent Agreement or other recoupment and disqualification agreement forms.

OVERISSUANCE PERIOD OI Begin Date FIP, SDA, CDC and FAP

The OI period begins the first month (or pay period for CDC) benefit issuance exceeds the amount allowed by policy **or** 72 months (6 years) before the date the OI was referred to the RS, whichever is later. To determine the first month of the OI period (for OIs 11/97 or later) Bridges allows time for:

- The client reporting period, per BAM 105.
- The full standard of promptness (SOP) for change processing, per BAM 220.
- The full negative action suspense period.

Note: For FAP simplified reporting, the household has until 10 days of the month following the change to report timely. See BAM 200.

OI End Date FIP, SDA, CDC and FAP

The OI period ends the month (or pay period for CDC) before the benefit is corrected.

IPV Hearings

FIP, SDA, CDC, MA and FAP

OIG represents DHS during the hearing process for IPV hearings. OIG requests IPV hearings when no signed DHS-826 or DHS-830 is obtained, and correspondence to the client is not returned as undeliverable, or a new address is located.

Exception: For FAP only, OIG will pursue an IPV hearing when correspondence was sent using first class mail and is returned as undeliverable.

OIG requests IPV hearing for cases involving:

1. FAP trafficking OIs that are not forwarded to the prosecutor.

- 2. Prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, **and**;
 - The total OI amount for the FIP, SDA, CDC, MA and FAP programs combined is or more, **or**;
 - The total OI amount is less than , and;
 - •• The group has a previous IPV, or;
 - •• The alleged IPV involves FAP trafficking, or;
 - •• The alleged fraud involves concurrent receipt of assistance (see BEM 222), **or**;
 - •• The alleged fraud is committed by a state/government employee.

Excluding FAP, OIG will send the OI to the RS to process as a client error when the DHS-826 or DHS-830 is returned as undeliverable and no new address is obtained.

BEM 222 CONCURRENT RECEIPT OF BENEFITS

DEPARTMENT POLICY All Programs

Concurrent receipt of benefits means assistance received from **multiple** programs to cover a person's needs for the same time period. Certain restrictions apply, as specified in this item.

Benefit duplication means assistance received from the same (or same type of) program to cover a person's needs for the same month. For example, FIP from Michigan and similar benefits from another state's cash assistance program. As specified in the balance of this item, benefit duplication is prohibited except for MA and FAP in limited circumstances (see MA Benefits and FAP Benefits in this item). See BEM 203, Criminal Justice Disqualifications, for penalties for individuals found to have received duplicate assistance.

MA Benefits MA and AMP Only

Assume an MA or AMP applicant is **not** receiving medical benefits from another state unless evidence suggests otherwise. Do **not** delay the MA/AMP determination. Upon approval, notify the other state's agency of the effective date of the client's medical coverage in Michigan.

FAP Benefits FAP Only

A person **cannot** be a member of more than one FAP Certified Group (CG) in any month.

A person **cannot** receive FAP in more than one state for any month.

In this case Respondent was receiving Medical Assistance (MA) and Food Assistance Program (FAP) benefits from Minnesota when she submitted her Michigan application. The fact that Claimant intentionally failed to inform Michigan she was already receiving the benefits, makes the over-issuance period begin the same day as the application. The evidence presented by the Department shows that Claimant received duplicate Medical Assistance (MA) and Food Assistance Program (FAP) benefits from May 3, 2007 until September 30, 2007. Department of Human Services Bridges Eligibility Manual (BEM) 222 (2013), shown above, prohibits duplicate receipt of FAP benefits. The policy does also for duplicate MA benefits but only for a short period during initial application and approval.

The evidence submitted by the Department alleges that all Respondent's Medical Assistance (MA) benefits from May 3, 2005 through March 31, 2008 were an over-issuance caused by Respondent's Intentional Program Violation (IPV). That is incorrect. Department of Human Services Bridges Administration Manual (BAM) 720 (2013), shown above, states that the OI period ends the month before the benefit is corrected. That makes September 30, 2007 the end of the over-issuance period for both Medical Assistance (MA) and Food Assistance Program (FAP) benefits. The evidence submitted by the Department shows that of Medical Assistance (MA) benefits were paid on behalf of Respondent during the over-issuance period.

A detailed analysis of the evidence presented, applicable Department policies, and reasoning for the decision are contained in the recorded record.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department has established by clear and convincing evidence that Respondent committed an Intentional Program Violation (IPV) which resulted in a over-issuance of Medical Assistance (MA) benefits and a over-issuance of Food Assistance Program (FAP) benefits that the Department is entitled to recoup and received Food Assistance Program (FAP) benefits from Michigan and Minnesota concurrently in violation of Department of Human Services Bridges Eligibility Manual (BEM) 222. This is Respondent's 1st Intentional Program Violation (IPV) of the Medical Assistance (MA) and Food Assistance Program (FAP) and the Department may disqualify Respondent from receiving Food Assistance Program (FAP) benefits in accordance with Department of Human Services Bridges Administration Manual (BAM) 720 (2013).

It is ORDERED that the actions of the Department of Human Services, regarding the Food Assistance Program (FAP), are **UPHELD**.

The Department is ORDERED to reduce the Medical Assistance (MA) over-issuance to for the period May 3, 2007 to September 30, 2007 in accordance with Department policy.
