AMENDED HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

This matter having come before the undersigned Administrative Law Judge, pursuant to MCL 400.9 and MCL 400.37, upon the Department of Human Services' (Department) Request for Hearing. After due notice, a telephone hearing was held on Tuesday, May 21, 2013, from Lansing, Michigan. At the conclusion of the hearing, a Hearing Decision was generated by Administrative Law Judge, Carmen G. Fahie, dated and mailed, June 13, 2013, which is hereby **AMENDED** to reflect the correct OIG agent that held the hearing of Cordelia Kemp, OIG Agent #109 and incorrectly input in the Hearing Decision mailed on June 13, 2013 and the Amended Hearing Decision mailed July 5, 2013. All Findings of Fact and Conclusions of Law remain unchanged and are incorporated herein by reference. The Department was represented by Cordelia Kemp, OIG Agent #109, of the Office of Inspector General (OIG).

☐ The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

When a Client group receives more benefits than they are entitled to receive, the Department must attempt to recoup the OI. BAM 700.

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The Client intentionally failed to report information, or intentionally gave incomplete, or inaccurate information needed to make a correct benefit determination, and;
- The Client was clearly and correctly instructed regarding his/her reporting responsibilities, and;
- The Client has no apparent physical, or mental, impairment that limits his/her understanding, or ability, to fulfill their reporting responsibilities.

IPV is suspected when there is clear and convincing evidence that the Client has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing, or preventing reduction of program benefits or eligibility. BAM 720.

The Department's OIG requests IPV hearings for cases when:

- benefit over-issuances are not forwarded to the prosecutor;
- prosecution of welfare fraud is declined by the prosecutor for a reason other than lack of evidence, and;
- the total over-issuance amount is \$1000 or more, or;
- the total over-issuance amount is less than \$1000, and:
 - the group has a previous intentional program violation, or;
 - the alleged IPV involves FAP trafficking, or;
 - the alleged fraud involves concurrent receipt of assistance:

 the alleged fraud is committed by a State/Government employee.

A court or hearing decision that finds a Client committed an IPV disqualifies that Client from receiving certain program benefits. A disqualified recipient remains a member of an active group as long as he lives with them. Other eligible group members may continue to receive benefits. BAM 720.

Clients who commit an IPV are disqualified for a standard disqualification period except when a court orders a different period, or except when the over-issuance relates to MA. Refusal to repay will not cause denial of current or future MA if the Client is otherwise eligible. BAM 710. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a concurrent receipt of benefits. BAM 720.

Additionally, the Respondent failed to report that she was receiving disability benefits while receiving FIP and FAP. As a result, the Respondent committed an IPV and received an over-issuance of FIP and FAP of In addition, the Claimant received CDC benefits, but she had school age children and she worked during the day. As a result, the Claimant received an over-issuance of CDC of Therefore, the Department has met their burden that the Claimant committed an IPV and received an over-issuance of FIP, FAP, and CDE benefits during the contested time period, which the Department is required to recoup.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, concludes that:
