The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2).

In the present case, Claimant requested a hearing to dispute the Department's action. Soon after commencement of the hearing, the parties testified that they had reached a settlement concerning the disputed action. Consequently, the Department agreed to do the following: Redetermine the Claimant's eligiblity for QMB back to the closure date and issue the Claimant any supplement that he may thereafter be due.

As a result of this settlement, Claimant's mother no longer wished to proceed with the hearing. As such, it is unnecessary for this Administrative Law Judge to render a decision regarding the facts and issues in this case.

## **DECISION AND ORDER**

The Administrative Law Judge concludes that the Department and Claimant have come to a settlement regarding Claimant's request for a hearing.

## THE DEPARTMENT IS ORDERED TO DO THE FOLLOWING:

1. Initiate action to redetermine the Claimant's eligibility for QMB back to the closure date and issue the Claimant any supplement he may thereafter be due.
