**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on January 7, 2013 from Detroit, Michigan. Participants included the above-named claimant. Participants on behalf of Department of Human Services (DHS) included [REDACTED], Specialist, and [REDACTED], Manager.

**ISSUE**

The issue is whether DHS properly terminated Claimant's eligibility for Food Assistance Program (FAP) benefits due to Claimant's failure to submit employment income verifications.

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant was an ongoing FAP benefit recipient.
2. Claimant's FAP benefits were scheduled for redetermination prior to the end of 10/2012.
3. On an unspecified date, Claimant submitted a Redetermination to DHS noting that he had employment income.
4. Claimant failed to submit employment income verification when he submitted the Redetermination.

5. On 10/2/12, DHS mailed Claimant a Verification Checklist (VCL) requesting verification of employment income.
6. The VCL due date was 10/22/12.
7. Claimant again failed to submit employment income verification.
8. On 11/10/12, DHS mailed Claimant a Notice of Case Action informing Claimant of a FAP benefit expiration as of 10/31/12, due to Claimant's failure to submit verification of employment income.
9. On 11/22/12, Claimant requested a hearing to dispute the FAP benefit termination.

### **CONCLUSIONS OF LAW**

The Food Assistance Program (formerly known as the Food Stamp Program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). DHS administers the FAP pursuant to Michigan Compiled Laws 400.10, *et seq.*, and Michigan Administrative Code R 400.3001-3015. DHS regulations are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).

The redetermination process begins with DHS mailing a redetermination packet in the month prior to the end of the benefit period. *Id* at 4. The packet consists of forms and requests for verification that are necessary for DHS to process the redetermination. The forms needed for redetermination may vary, though a Redetermination (DHS-1010) is an acceptable review form for all programs. Verifications for redetermination must be provided by the end of the current benefit period or within 10 days after they are requested, whichever allows more time. *Id* at 12.

The present case involves a lapse of FAP benefits due to an alleged failure by Claimant to verify asset information. Assets must be considered in determining eligibility for FAP. BEM 400 (11/2012), p. 1.

The present case concerns a FAP benefit redetermination. Claimant's benefit period was scheduled for redetermination prior to the end of 10/2012. It was not disputed that Claimant submitted a Redetermination to DHS, but failed to submit check stubs with the Redetermination, or after DHS requested the stubs via VCL. Claimant stated that he submitted the check stubs to DHS after his case closed; the submission was after the benefit period expired and more than 10 days after verification was requested. Once Claimant's case closed, he could only regain FAP benefit eligibility by reapplying. Based on the presented evidence, DHS properly allowed Claimant's FAP benefit eligibility to end 10/31/12 due to Claimant's failure to verify employment income.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that DHS properly terminated Claimant's FAP benefit eligibility effective 10/2012, due to Claimant's failure to verify employment income. The actions taken by DHS are AFFIRMED.

**NOTICE:** Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases)

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.

Claimant may request a rehearing or reconsideration for the following reasons:

- A rehearing **MAY** be granted if there is newly discovered evidence that could affect the outcome of the original hearing decision.
- A reconsideration **MAY** be granted for any of the following reasons:
  - misapplication of manual policy or law in the hearing decision,
  - typographical errors, mathematical error, or other obvious errors in the hearing decision that effect the substantial rights of the claimant:
  - the failure of the ALJ to address other relevant issues in the hearing decision.
